A BILL

FOR AN ACT MAKING APPROPRIATIONS FOR THE IOWA HOSPITAL FOR THE
INSANE AT MT. PLEASANT.

SECTION 1. *Be it enacted by the General Assembly of the State of Iowa,* That there is hereby
2 appropriated, out of any money in the treasury not otherwise appropriated, the following
3 sums for the purposes herein named, viz:

4	For completing sub-basement.....	\$6,000
5	For blacksmith shop	500
6	For smoke and meat house	1,500
7	For enlargement of filter and repair of reservoirs	2,500
8	For division of airing courts and partitions	600
9	For water-closets for dormitories and airing courts.....	600
10	For drying-rooms in basement	400
11	For hose and couplings.....	400
12	For wire mattresses and iron bedsteads.....	500
13	For general repairs	5,000
14	For contingencies.....	1,000

SEC. 2. The money herein appropriated shall be drawn and paid on the order of the trus-
2 tees of said hospital at such times as may be deemed necessary by said trustees: *provided,*
3 that the amount herein appropriated for general repairs, contingencies and for completing

4 sub-basement, and other appropriations, shall not be drawn except as the causes arise or
5 work progresses requiring the expenditure.

SEC. 3. This act being deemed of immediate importance, shall take effect and be in force
2 from and after its publication in the *Iowa State Register*, a newspaper published at Des Moines,
3 Iowa, and the *Mt. Pleasant Journal*, a newspaper published at Mt. Pleasant, Iowa.

A BILL

FOR AN ACT MAKING APPROPRIATIONS FOR THE IOWA HOSPITAL FOR THE INSANE AT MT. PLEASANT.

SECTION 1. *Be it enacted by the General Assembly of the State of Iowa,* That there is hereby
2 appropriated, out of any money in the treasury not otherwise appropriated, the following
3 sums for the purposes herein named, viz.:

4	For completing sub-basement.....	\$11,237.50
5	For improving grounds, planting trees and grading	2,500.00
6	For building barn.....	4,200.00
7	For lumber room	450.00
8	For blacksmith shop	1,050.00
9	For smoke and meat house	1,900.00
10	For enlargement of filter and repair of reservoirs.....	2,800.00
11	For division of airing courts and partitions	1,100.00
12	For water-closets for dormitories and airing courts.....	1,200.00
13	For drying-rooms in basement.....	400.00
14	For hose and couplings	450.00
15	For wire mattresses and iron bedsteads	2,500.00
16	For general repairs	9,000.00
17	For contingencies	2,000.00

SEC. 2. The money herein appropriated shall be drawn and paid on the order of the trus-
2 tees of said hospital, at such times as may be deemed necessary by said trustees: *provided,*
3 that the amount herein appropriated for general repairs, contingencies and other appropria
4 tions and for completing sub-basement shall not be drawn except as the causes arise or work
5 progresses, requiring the expenditure: *provided further,* that any money remaining unexpended

6 after the completion of the improvement for which the same is herein appropriated may be
7 used as far as necessary for any purpose specified in this act.

SEC. 3. This act being deemed of immediate importance, shall take effect and be in force
2 from and after its publication in the *Iowa State Register*, a newspaper published at Des Moines,
3 and the *Mt. Pleasant Journal*, a newspaper published at Mt. Pleasant.
