

A BILL

FOR AN ACT MAKING AN APPROPRIATION FOR ERECTING AN ADDITIONAL WING TO THE IOWA HOSPITAL FOR THE INSANE AT MT. PLEASANT FOR FEMALE PATIENTS.

Be it enacted by the General Assembly of the State of Iowa:

SECTION 1. That for the purpose of erecting an additional wing to the Iowa Hospital for
2 the Insane at Mt. Pleasant, for female patients, the sum of one hundred thousand dollars
3 (\$100,000) is hereby appropriated, out of any money in the State Treasury not otherwise ap-
4 propriated. The amount herein named shall be for the erection of a good substantial stone
5 structure for the proper accommodation of two hundred female patients, with the neces-
6 sary attendants and employes for their care, and for heating apparatus, gas fixtures, and
6 furnishing the same ready for occupancy.

SEC. 2. The Superintendent of said hospital, under the direction of the Board of Trustees,
2 shall have general charge and supervision of the work of constructing and furnishing this
3 addition.

SEC. 3. No plan shall be adopted or contract let which shall involve the expenditure of
2 more money than is herein appropriated.

SEC. 4. The proposed wing shall be completed and ready for occupancy on or before Janu-
2 ary 1, 1888.

SEC. 5. The money herein appropriated shall be drawn and paid on the order of the
2 trustees of said hospital at such times as may be deemed necessary by said trustees: Pro-
3 vided that not more than one-half of the amount herein appropriated shall be drawn dur-
4 ing the year 1886.

SEC. 3. This act, being deemed of immediate importance, shall take effect and be in force
2 from and after its publication in the Iowa State Leader and the Iowa State Register, news-
3 papers published at Des Moines, Iowa.

A BILL

FOR AN ACT MAKING AN APPROPRIATION FOR ERECTING AN ADDITIONAL WING TO THE IOWA HOSPITAL FOR THE INSANE AT MT. PLEASANT, FOR FEMALE PATIENTS, AND FOR THE SUPPORT OF SAID HOSPITAL.

Be it enacted by the General Assembly of the State of Iowa:

SECTION 1. That for the purpose of erecting an additional wing to the Iowa Hospital for
2 the Insane at Mt. Pleasant, the sum of one hundred thousand dollars (\$100,000), or so much
3 thereof as may be necessary, is hereby appropriated out of any money in the State treas-
4 ury not otherwise appropriated. The amount herein named shall be for the erection of a
5 good substantial stone structure for the proper accommodation of two hundred patients,
6 with the necessary attendants and employes for their care and for heating apparatus, gas
7 fixtures, and furnishing the same for occupancy.

SEC. 2. The superintendent of said hospital, under the direction of the board of trustees,
2 shall have general charge and supervision of the work of constructing and finishing this
3 addition.

SEC. 3. No plan shall be adopted or contract let which shall involve the expenditure of
2 more money than is herein appropriated.

SEC. 4. The proposed wing shall be completed and ready for occupancy by July 1, 1887.

SEC. 5. The money herein appropriated shall be drawn quarterly and paid on the order
2 of the trustees of said hospital as follows: \$20,000 on July 1, 1886; \$20,000 October 1, 1886;
3 \$20,000 on January 1, 1887; \$20,000 April 1, 1887, (or so much thereof as may be necessary);
4 \$20,000 July 1, 1887, (or so much thereof as may be necessary).

SEC. 6. For the contingent fund of said hospital the sum of \$6,000.00; total amount ap-
2 propriated by this bill, \$106,000.00. Provided, however, that not more than one-half of said
3 contingent fund be drawn in the year 1886, and the remainder quarterly during the year
4 1887.

SEC. 7. This act being deemed of immediate importance shall take effect and be in force
2 from and after its publication in the Iowa State Register and the Des Moines Leader,
3 newspapers published at Des Moines, Iowa.
