FOR AN ACT TO AMEND SECTION 1427 OF THE CODE AS AMENDED BY THE SEVENTEENTH GENERAL ASSEMBLY. ALSO SECTION 1676 OF THE CODE AS AMENDED BY THE SEVENTEENTH AND EIGHTEENTH GENERAL ASSEMBLYS. ALSO SECTION 1692 OF THE CODE AS AMENDED BY THE SEVENTEENTH AND EIGHTEENTH GENERAL ASSEMBLYS. ALSO SECTION 1630 OF THE CODE OF 1873, AND ALSO SECTION 5, CHAPTER 152, ACTS OF THE SIXTEENTH GENERAL ASSEMBLY, RELATING TO THE SUPPORT OF THE VARIOUS CHARITABLE INSTITUTIONS OF THE STATE.

Be it enacted by the General Assembly of the State of Iowa :

SECTION 1. That section 1427 of the Code as amended by the Seventeenth General Assembly be and the same is hereby amended by striking out the word "sixteen" in the third line of said section and inserting the word "twelve" in lieu thereof.

SEC. 2. That section 1692 of the Code as amended by the Seventeenth and Eighteenth General Assemblys be and the same is hereby amended by striking out the words "twenty-eight," in the second line of said section and inserting the words "twenty-four" in lieu thereof.

SEC. 3. That section 1676 of the Code as amended by the Seventeenth and Eighteenth General Assemblys, be and the same is hereby amended by striking out the word "thirty-two," in the third line of said section and inserting the word "thirty" in lieu thereof.

SEC. 4. That section 1630 of the Code of 1873, be and the same is hereby amended by striking out the word "ten" in the third line of said section and inserting the word "nine" in lieu thereof.

SEC. 5. That section 5⁷ chapter 152, acts of the Sixteenth General Assembly be and the same is hereby amended by striking out the word "ten" in the third line of said section and inserting "nine" in lieu thereof.

FOR AN ACT TO AMEND SECTION 1427 OF THE CODE AS AMENDED BY CHAPTER 84, SECTION 1, ACTS OF THE SEVENTEENTH GENERAL ASSEMBLY. AND ALSO SECTION 1630 OF THE CODE. AND ALSO SECTION 7, CHAPTER 152, ACTS OF THE SIXTEENTH GENERAL ASSEMBLY. AND ALSO SECTION 1676 OF THE CODE AS ENACTED BY SECTION 2, CHAPTER 166, ACTS OF THE NINETEENTH GENERAL ASSEMBLY. AND SECTION 1692 OF THE CODE AS AMENDED BY SECTION 1, CHAPTER 105, ACTS OF THE NINETEENTH GENERAL ASSEMBLY.

Be it enacted by the General Assembly of the State of Iowa:

SECTION 1. That section 1427 of the Code as amended by section 1, chapter 84, acts of the
2 Seventeenth General Assembly be and the same is hereby amended by striking out the
3 word "sixteen," in the 3rd line and inserting the word "twelve," in lieu thereof.

SEC. 2. That section 1630 of the Code be and the same is hereby amended by striking out
2 the word "ten," in the third line and inserting "nine," in lieu thereof.

SEC. 3. That section 7, chapter 152, acts of the Sixteenth General Assembly be and the
2 same is hereby amended by striking out the word "ten," in the third line and inserting in
3 lieu thereof the word "nine."

SEC. 4. That section 1676 of the Code as enacted by section 2, chapter 166, acts of the
2 Nineteenth General Assembly be and the same is hereby amended by striking out the word
3 "forty," in the third line and inserting the word "thirty-two," in lieu thereof.

SEC. 5. That section 1692 of the Code as amended by section 1, chapter 105, acts of the
2 Nineteenth General Assembly be and the same is hereby amended by striking out the word
3 "thirty-five," and inserting the word "twenty-eight," in lieu thereof.
