A BILL FOR

An Act to legalize the corporate acts and proceedings in connection with the renewal of the corporate existence and the adoption of the amended and substituted articles of incorporation of the Boomhower Hardware Company and to provide for the renewal of the charter of the said Boomhower Hardware Company.

WHEREAS, the period of the corporate existence of the Boomhower Hardware Company, a corporation organized under the laws of the state of Iowa, with its principal place of business in the city of Mason City, Iowa, expired on the ninth day of July, 1937, and through inadvertence the same was not renewed within the period prescribed by statute, and

WHEREAS, the Boomhower Hardware Company has continued thereafter to conduct its business and affairs as a corporation, and

WHEREAS, on the thirty-first day of October, 1946, the adjourned annual meeting of the stockholders of the said corporation was called by the president for the purpose of renewing and extending the said corporation for a period of twenty (20) years from July 9, 1937, and adopting the amended and substituted Articles of Incorporation, and

WHEREAS, the Boomhower Hardware Company has filed the said Amended and Substituted Articles of Incorporation together with a notice of renewal of the said corporation with the secretary of state of the state of Iowa, and has paid the proper renewal fees and recording fees, and has in all other particulars complied with the provisions of the statutes relating to renewals of corporations,

NOW THEREFORE

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. That all proceedings had with respect to the
2 renewal of the corporate existence of the Boomhower Hardware
3 Company, a corporation, with its principal place of business in
4 Mason City, Iowa, and all corporate acts of said corporation,
5 its officers and directors, since the expiration of the corporate
6 existence of said corporation on the ninth day of July, 1937,
7 are hereby legalized and shall have the same force and effect as
8 though the said proceedings have been adopted pursuant to law
9 and within the period prescribed by the statute, and shall be
10 held and considered as a renewal and extension of the period of
11 the corporate existence of said corporation, which expired on
12 July 9, 1937, and all corporate acts and proceedings in
13 connection with the renewal and existence of said corporation and
14 and the adoption of the renewal, amended and substituted Articles
15 of Incorporation, are hereby declared to be valid and legal.

1 Sec. 2. The secretary of state is hereby authorized and
2 directed to acknowledge and file for record the notice of renewal
3 of said corporation previously delivered to him by said
4 corporation, and to issue a Certificate of Renewal to the
5 Boomhower Hardware Company, said renewal to extend the corporate
6 existence of said Corporation for a period of twenty (20) years
7 from July 9, 1937, which Certificate of Renewal shall have the
8 same force and effect as though issued upon proper and timely
9 application by said Corporation.

1 Sec. 3. Nothing in this act shall be deemed or construed

2 to affect pending litigation, if any, involving said Corporation.

1 Sec. 4. This act being deemed of immediate importance

2 shall take effect and be in force from and after its publication
