A BILL FOR

An Act to amend chapter one hundred ninety-nine (109), Code 1946, relating to agricultural seeds.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Amend section one hundred ninety-nine
2 point one (199.1) Code 1946, by adding a new subsection to
3 provide as follows: "The term "vegetable seeds" shall include
4 the seeds of those crops which are grown in gardens or on
5 truck farms and for commercial canning purposes and are
6 generally known and sold under the name of vegetable seeds in
7 this state."

8 Further amend said section by adding after the word
9 agricultural in line one (1) of subsection five (5) the words
10 "or vegetable".

11 Amend subsection seven (7) by adding "or vegetable"
12 following the word agricultural in line one (1).

1 Sec. 2. Amend section one hundred ninety-nine
2 point three (199.3) by adding the words "or vegetable" after
3 the word agricultural in line one (1).

4 Further amend said section by adding after the

5 word agricultural in line one (1) in subsection one (1) the
6 words “or vegetable”.

7 Further amend said section by adding the words
8 “or vegetable” following the word agricultural in line three
9 (3) of paragraph a. of subsection one (1).

10 Amend paragraph f. by adding the words
11 “or vegetable” following the word agricultural in line one (1)
12 of subsection one (1).

13 Amend paragraph h. by adding the words
14 “or vegetable” following the word agricultural in line one (1)
15 of subsection one (1).

1 Sec. 3. Amend section one hundred ninety-nine point
2 four (199.4) by adding the words “or vegetable” following
3 the word agricultural in line one (1).

1 Sec. 4. Amend section one hundred ninety-nine point
2 eight (199.8) by adding the words “or vegetable” following the
3 word agricultural in line one (1) of subsection one (1).

1 Sec. 5. Amend section one hundred ninety-nine point
2 ten (199.10) by adding the words “or vegetable” after the
3 word agricultural in line three (3) of subsection two (2).

4 Further amend said section by adding the words
5 “or vegetable” following the word agricultural in line eleven
6 (11) of subsection three (3).

1 Sec. 6. Amend section one hundred ninety-nine
2 point eleven (199.11) by adding the words “or vegetable”
3 following the word agricultural in line six (6) and by adding

4 the words "or vegetable" following the word agricultural in
5 line ten (10).

6 Further amend said section by adding the words
7 "and vegetable" following the word agricultural in line five (5)
8 of subsection two (2).

9 Further amend said section by adding the words
10 "or vegetable" following the word agricultural in line three (3)
11 of subsection four (4).

1 Sec. 7. Amend section one hundred ninety-nine
2 point twelve (199.12) by adding the words "or vegetable"
3 following the word agricultural in line eight (8).

EXPLANATION OF H. F. 146

This bill was suggested by the cannery association. It seems that sweet corn varies in varieties as to the percentage of edible products which it might produce, as well as the yield of other vegetable products from the better seeds. It seems that some seed companies have a habit of collecting old seeds from other states that forbid their sale and re-selling them in Iowa, and it is this practice that we are trying to curb. Very little sweet corn or other garden seeds are raised in the state of Iowa, and this act will not materially affect any one except the out of state seed men.
