A BILL FOR

An Act to legalize and validate the proceedings authorizing and providing for the issuance, sale and delivery of school building bonds by the Consolidated Independent School District of Vinton, in the County of Benton, state of Iowa, and the provisions made for taxes for the payment of said bonds and declaring said bonds issued pursuant to said proceedings to be enforceable obligations of said school district.

WHEREAS, the Board of Directors of the Consolidated Independent School District of Vinton, in the county of Benton, State of Iowa, did heretofore by resolution and in reliance upon an election theretofore held in and for said school district authorize and provide for the issuance and delivery of School Building Bonds of said School District in the principal amount of three hundred and fifty thousand dollars (\$350,000) for the purpose of building and furnishing a new school house and procuring a site therefor, constructing and equipping a new bus garage and procuring a site therefor and reconstructing and equipping the present school houses in Vinton, Iowa, in and for said School District and by said resolution provided for the payment of the interest on and principal of said bonds by the levy and collection of annual taxes on all the taxable property in said School District; and

WHEREAS doubts have arisen concerning the validity and legal sufficiency of said bonds and proceedings and the provisions made for the payment of same, and it is deemed advisable to put said doubts and all others that might arise concerning same forever at rest; Now, Therefore,

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. That all proceedings heretofore taken by
2 the Board of Directors of the Consolidated Independent School
3 District of Vinton, in the County of Benton, State of Iowa,
4 authorizing and providing for the issuance, sale and delivery
5 of School Building Bonds by the Consolidated Independent School
6 District of Vinton, in the County of Benton, State of Iowa,
7 and providing for the levy and collection of annual taxes to
8 pay the interest on and principal of said bonds, are hereby
9 legalized, validated and confirmed, and said School Building
10 Bonds issued, sold and delivered pursuant to and in accordance
11 with said proceedings are hereby declared to be legal and to
12 constitute valid and binding obligations of said School
13 District.

1 Sec. 2. This act being deemed of immediate importance
2 shall take effect and be in force from and after its publication
3 in the Cedar Valley Daily Times, a newspaper published in the
4 City of Vinton, Iowa, and in the
5 Belle Plaine Union, a newspaper published in the
6 City of Belle Plaine, Iowa, all without expense to
7 the state.
