By BOARD OF CONTROL.

A BILL FOR

An Act relating to salaries of officials and employees of
 institutions under the supervision of the board of control.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section two hundred nineteen point nine
 2 (219.9), Code 1946, is amended by striking from lines two and
 3 three (2 and 3) the words, "an annual salary of three thousand
 4 dollars" and inserting in lieu thereof the words, "such annual
 5 salary as the board of control may determine".

1 Sec. 2. Section two hundred twenty-one point two (221.2),
 2 Code 1946, is amended by striking from lines four, five and six
 3 five (4 and 5) the words, "a salary not exceeding thirty-nine
 4 hundred dollars per annum" and inserting in lieu thereof the
 5 words, "such annual salary as shall be determined by the board
 6 of control".

1 Sec. 3. Section two hundred twenty-three point two
 2 (223.2), Code 1946, is amended by striking from lines four and
 3 five (4 and 5) the words, "a salary not exceeding thirty-nine
 4 hundred dollars per annum" and inserting in lieu thereof the
 5 words, "such salary as the board of control shall determine".

1 Sec. 4. Section two hundred twenty-six point four (226.4),

2 Code 1946, is amended by striking all of lines three and four
3 (3 and 4) and inserting in lieu thereof the following, "be
4 determined by the board of control".

1 Sec. 5. Section two hundred twenty-six point six (226.6),
2 Code 1946, is amended by striking the word, "entire" in line
3 three (3) and by adding the end of line five (5) the words,
4 "subject to the approval of the board of control".

1 Sec. 6. Section two hundred forty-two point three (242.3),
2 Code 1946, is hereby repealed and the following enacted in lieu
3 thereof:

4 "The salaries of the superintendents of the training schools
5 shall be determined by the board of control."

1 Sec. 7. Section two hundred forty-four point two (244.2),
2 Code 1946, is amended by striking from lines two and three (2
3 and 3) the words, "two thousand seven hundred fifty dollars per
4 year" and insertitng in lieu thereof the words, "determined by
5 the board of control".

1 Sec. 8. Section two hundred forty-five point two (245.2),
2 Code 1946, is amended by striking from lines three and four
3 (3 and 4) the words, "of not to exceed twenty-four hundred
4 dollars per year" and inserting in lieu thereof the words, "as
5 determined by the board of control".

1 Sec. 9. Section two hundred forty-six point two (246.2),
2 Code 1946, is hereby repealed and the following enacted in lieu
3 thereof, "The warden, deputy warden, assistant deputy warden,
4 chief clerk, chaplain, additional chaplain, physician, storekeêper,

5 record clerk, and receiving officer of the penitentiary and men's
6 reformatory shall receive such salaries as shall be determined by
7 the board of control."

1 Sec. 10. Section two hundred forty-six point three (246.3),
2 Code 1946, is hereby repealed and the following enacted in lieu
3 thereof:

4 "Captains, inspectors, turnkeys, guards first class, guards
5 second class, and guards third class shall receive such compen-
6 sation as shall be determined by the board of control and in
7 addition shall receive a midshift meal when on duty."

EXPLANATION OF H. F. 218

This bill permits the board of control to set the salaries of employees of the institutions under its supervision within the bounds of the appropriation made by the general assembly.
