A BILL FOR

An Act to appropriate from the general fund and from institutional industries fund of the state of Iowa for the biennium beginning July 1, 1947, and ending June 30, 1949, to the board of control for support of the institutions under said board of control.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated from the
2 general fund of the state and from institutional industries
3 fund of the state of Iowa for each year of the biennium
4 beginning July 1, 1947, and ending June 30, 1949, for the
5 board of control of state institutions for salaries,
6 support, maintenance, repairs, replacements or alterations
7 and miscellaneous purposes for all institutions under the
8 control of said board the sum of seven million eighty eight
9 thousand fifty dollars (\$7,088,050.00) from the general fund
10 and one hundred thousand dollars (\$100,000.00) from the
11 industries fund or so much thereof as may be necessary to be
12 used for the following purposes to-wit:

Cherokee

2 Iowa, there is hereby appropriated from the general fund
 3 of the state for each year of the biennium beginning

 6 thereof as may be necessary to be used in the following manner:
