A BILL FOR

An Act to legalize the corporate acts and proceedings in connection with the renewal of the corporate existence and the adoption of amended, substituted and renewal articles of incorporation of Fidelity Fireworks Company, and to provide for the renewal of the charter of said Company.

WHEREAS, the period of the corporate existence of the Fidelity Fireworks Company, a corporation, organized under the laws of the State of Iowa, with its principal place of business in the City of Fort Dodge, Iowa, expired on the 2nd day of February, 1945, and through inadvertence the same was not renewed within the period prescribed by statute, AND

WHEREAS, Fidelity Fireworks Company has continued thereafter to conduct its business and affairs as a corporation, AND

WHEREAS, on the 5th day of April, 1947, a special meeting of the stockholders was called and held for the purpose of extending and renewing the said corporation for a period of twenty years from February 2, 1945, and adopting the amended, substituted and renewal articles of incorporation, AND

WHEREAS, Fidelity Fireworks Company has filed the said amended, substituted and renewal articles of incorporation, together with a certificate of renewal of such corporation, with the Secretary of State of the State of Iowa, and has paid the proper renewal fees and recording fees, and has in all other particulars complied with the provisions of the statutes relating to renewals of corporations, Now,
Therefore,

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. All proceedings had with respect to the
2 renewal of the corporate existence of Fidelity Fireworks
3 Company, a corporation with its principal place of business
4 in Fort Dodge, Iowa, and all corporate acts of said corpora-
5 tion, its officers and stockholders, since the expiration
6 of the corporate existence of said corporation on the 2nd
7 day of February, 1945, are hereby legalized and shall have
8 the same force and effect as though the said proceedings had
9 been adopted pursuant to law and within the period pre-
10 scribed by the statute, and shall be held and considered as
11 a renewal and extension of the period of the corporate
12 existence of said corporation, which expired on February 2,
13 1945, and all corporate acts and proceedings of said
14 corporation, including the proceedings in connection with the
15 renewal and extension of said corporation and the adoption of
16 the amended, substituted and renewal articles of incorpora-
17 tion, are hereby declared to be valid and legal.

1 Sec. 2. The Secretary of State is hereby authorized
2 and directed to acknowledge and file and record the certifi-
3 cate of renewal of said corporation previously delivered to
4 him by said corporation, and to issue a certificate of
5 renewal to Fidelity Fireworks Company, said renewal to extend
6 the corporate existence of said corporation for a period of
7 twenty (20) years from February 2, 1945, which certificate of
8 renewal shall have the same force and effect as though issued
9 upon proper and timely application of said corporation.

1 Sec. 3. Nothing in this act shall be deemed or
2 construed to affect pending litigation, if any, involving
3 said corporation, or any claims outstanding against said
4 corporation.

1 Sec. 4. This act, being deemed of immediate importance,
2 shall be in full force and effect from and after its passage
3 and publication in Fort Dodge Messenger and Chronicle,
4 a newspaper published in Fort Dodge, Iowa, and in
5 The Dayton Review, a newspaper published in Dayton, Iowa,
6 without expense to the State of Iowa.
