## A BILL FOR

An Act making appropriations for payment of miscellaneous expenses of the Fifty-second General Assembly.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. There is hereby appropriated out of any funds  
 2 in the state treasury, not otherwise appropriated, the following  
 3 sums, or so much thereof as may be necessary in payment of  
 4 miscellaneous expenses of the Fifty-second General Assembly:

5	Lillian Leffert for special services rendered	
6	for the Fifty-second General Assembly.....	\$ 150.00
7	Robert Sandler, for pre-session bill drafting.....	55.00
8	A. C. Gustafson, for services rendered subsequent	
9	to adjournment of the Fifty-first General	
10	Assembly and prior to the pre-session services	
11	of the Fifty-second General Assembly.....	750.00
12	American Signal Corporation for special terminals	
13	and key tags for voting machine.....	61.96
14	A. C. Gustafson, chief clerk of the house, for	
15	postage and miscellaneous expenses after	
16	adjournment. (This shall be in addition to	
17	postage left over in house post office after	

18	session has adjourned.).....	150.00
19	W. J. Scarborough, secretary of the senate, for	
20	postage and miscellaneous expenses after

1     Sec. 2. There is hereby appropriated a sum sufficient to pay  
2 the per diem compensation made necessary by House Concurrent  
3 Resolution 22 for services required of officers and employees of  
4 the Fifty-second General Assembly after final adjournment.

1     Sec. 3. There is hereby appropriated to the Executive Council  
2 the sum of six thousand seven hundred thirty-four dollars and  
3 thirty-two cents (\$6,734.32) for legislative supplies and equipment  
4 purchased for the Fifty-second General Assembly.

1     Sec. 4. There is hereby appropriated to the Executive Council  
2 the sum of two thousand seven hundred dollars (\$2,700.00) for the  
3 cost of legislative supplies purchased from the Klipto Company of  
4 Mason City, Iowa.

1     Sec. 5. There is hereby appropriated to the Executive Council  
2 a sum sufficient to defray the expenses of wiring necessary for the  
3 temporary lighting and loud speaker system used during the Fifty-  
4 second General Assembly but said funds appropriated by this act shall  
5 not be expended until approved by the joint legislative committee on



1      Sec. 9. This act being deemed of immediate importance shall  
2 be in full force and effect after its passage and publication in the  
3 Cedar Valley Times, a newspaper published at Vinton,  
4 Iowa, and the Spencer Daily Reporter, a newspaper published at  
5 Spencer, Iowa.
