A BILL FOR

An Act to make an emergency appropriation to the state board of education for salaries, support, and maintenance of the university hospital, Iowa City, Iowa, the bacteriological laboratory, Iowa City, Iowa, the Iowa state teachers college, Cedar Falls, Iowa, and the Iowa school for the blind, Vinton, Iowa.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated out of any money
2 in the state treasury, not otherwise appropriated, the sum of
3 four hundred thirty-one thousand two hundred and sixty (431,260.00)
4 dollars as an emergency appropriation, or as much thereof as may
5 be necessary, for the remainder of the fiscal year 1946-1947, to
6 be used in the following manner and for the following purposes,
7 to wit:
8 Medical and surgical treatment
9 of indigent persons, State University Hospital
10 1. For the purpose of carrying out the purpose of chapter
11 two hundred fifty-five (255), Code 1946, there is hereby appro-
12 priated out of any money in the state treasury, not otherwise
13 appropriated, the sum of two hundred ninety-four thousand
14 (294,000.00) dollars as an emergency appropriation, or as much
15 thereof as may be necessary, to be used in the manner and under

16 the authority provided in said chapter for the remainder of the
17 fiscal year 1946-1947.

18 Bacteriological Laboratory

19 2. For the bacteriological laboratory, at Iowa City,
20 for the remainder of the fiscal year 1946-1947, there is here-
21 by appropriated out of any money in the state treasury, not
22 otherwise appropriated, the sum of two thousand five hundred
23 and sixty (2,560.00) dollars as an emergency appropriation,
24 or as much thereof as may be necessary, to be used in the
25 manner and under the authority provided in chapter two hun-
26 dred sixty-three (263), Code 1946.

27 Iowa State Teachers College

28 3. For the salaries, support, and maintenance of the
29 Iowa state teachers college, Cedar Falls, Iowa, there is
30 hereby appropriated out of any money in the state treasury,
31 not otherwise appropriated, the sum of one hundred thirty-
32 one thousand two hundred (131,200.00) dollars as an emergency
33 appropriation, or as much thereof as may be necessary, for
34 the remainder of the fiscal year 1946-1947.

35 Iowa School For The Blind

36 4. For the salaries, support, and maintenance of the
37 Iowa school for the blind, Vinton, Iowa there is hereby
38 appropriated out of any money in the state treasury, not
39 otherwise appropriated, the sum of three thousand five hundred
40 (3,500.00) dollars as an emergency appropriation, or as much
41 thereof as may be necessary, for the remainder of the fiscal

42 year 1946-1947.

43 Grand total of all appropriations for all purposes for
 44 the remainder of the fiscal year 1946-1947 for institutions
 45 under the State board of education.....\$432,260.00.

1 Sec. 2. The appropriations provided for in this act shall
 2 be expended under the direction of the Iowa state board of
 3 education.

1 Sec. 3. The appropriations provided for in this act, shall
 2 be available on March 1st, 1947, or at any time thereafter, and
 3 shall be paid on the order of the Iowa state board of education.

1 Sec. 4. This act being deemed of immediate importance
 2 shall be in full force and effect from and after its publication
 3 in, a newspaper published at
