A BILL FOR

An Act to amend chapter three hundred seventeen (317), Code 1946, relating to weeds.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Amend section three hundred seventeen point
2 three (317.3), Code 1946, by striking therefrom the following:
3 the word "either" in line two (2) thereof; and from lines three
4 (3), four (4), five (5) and six (6) the following: "or one (1)
5 township weed commissioner for each township, whose term or
6 terms of office shall not exceed one (1) year"; also from
7 lines eight (8) and nine (9) the following: ", whose term of
8 office shall not exceed one (1) year"; also from lines thirteen
9 (13) and fourteen (14) the following: "or township commissioners".
10 Further amend said section by adding the following: "All land
11 owners and tenants thereof are hereby appointed and designated
12 as deputy weed commissioners whose tenure of office shall
13 continue until they have ceased to be land owners or tenants.
14 No compensation shall be payable to deputy commissioners unless
15 allowed by the Board of Supervisors. Said commissioners shall
16 not be required to qualify as now required by law by public
17 officers.

1 Sec. 2. Amend section three hundred seventeen point four
2 (317.4), Code 946, by striking from line five (5) thereof the
3 word “township,”.

1 Sec. 3. Amend section three hundred seventeen point
2 'six (317.6), Code 1946, by striking the word “ten” in line
3 five (5) and inserting in lieu thereof the word “five”.

1 Sec. 4. Amend subsection two (2) of section three hundred
2 seventeen point eight (317.8), Code 1946, by inserting after
3 the word “weed” in line three (3) of said subsection the
4 following: “appearing in the state”.

1 Sec. 5. Amend section three hundred seventeen point
2 eleven (317.11), Code 1946, by striking the word “primary”
3 appearing in lines two (2) and five (5) thereof.

1 Sec. 6. Amend section three hundred seventeen point
2 twelve (317.12), Code 1946, by striking the word “primary”
3 from lines six (6) and eight (8) thereof.

1 Sec. 7. Amend section three hundred seventeen point
2 thirteen (317.13), Code 1946, by striking the word “township”
3 from line four (4), and by striking the word “primary from
4 line ten (10), and by striking the word “other” from line
5 twelve (12) thereof.

1 Sec. 8. Amend section three hundred seventeen point
2 eighteen (317.18), Code 1946, by striking the word “primary”
3 from line three (3) thereof, and by striking the following
4 from line seventeen (17): “or township”.

1 Sec. 9. Further amend said chapter by adding the

2 following: "An additional one-fourth ($\frac{1}{4}$) mill may be levied
3 by the county board of supervisors for the purpose of
4 purchasing weed eradicating equipment and materials to carry
5 out the duties of the county weed commissioner for use on all
6 lands in the county, public or private. Such equipment and
7 its use shall be subject to the authorization and direction
8 of the county board of supervisors."

1 Sec. 10. Amend section three hundred seventeen point
2 sixteen (317.16), Code 1946, by adding the following: "Such
3 charges against the property owner shall include an additional
4 charge of twenty-five (25) per cent of actual weed eradication
5 to cover costs of supervision and administration."
