By APPROPRIATIONS COMMITTEE.

A BILL FOR

An Act to transfer the control of funds heretofore appropriated and set aside for use at the state sanatorium at Oakdale.

WHEREAS, the 49th General Assembly in chapter 3 appropriated the sum of twenty-two thousand five hundred dollars (\$22,500.00) to the board of control for improvements and equipment at the state sanatorium at Oakdale, Iowa; and,

WHEREAS, chapter 3, Acts of the 51st General Assembly, appropriated to the board of control for the construction of new buildings, repairs, improvements, replacements or alterations, the sum of seven hundred thousand dollars (\$700,000.00) to be used at the state sanatorium at Oakdale, Iowa; and,

WHEREAS, due to conditions beyond the control of the board of control and the committee on retrenchment and reform, said funds have not been expended; and,

WHEREAS, Senate File 70, Acts of the 52d General Assembly was enacted by the legislature and approved by the governor on March 27, 1947; and,

WHEREAS, the supervision of the state sanatorium at Oakdale was, by the provisions of Senate File 70, transferred from the board of control to the board of education; and,

WHEREAS, it is deemed necessary and proper to transfer said sums or the balance thereof to the board of education in order to carry out the intent of the legislature and the purposes for which said sums were appropriated; Now, therefore,

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. The twenty-two thousand five hundred dollars
- 2 (\$22,500.00), or the balance thereof, appropriated by chapter 3,
- 3 Acts of the 49th General Assembly to the state sanatorium at

4 Oakdale for improvements and equipment and the sum of seven
5 hundred thousand dollars (\$700,000.00), or the balance thereof,
6 appropriated by chapter 3, Acts of the 51st General Assembly,
7 for the construction of new buildings, repairs, improvements,
8 replacements or alterations at the state sanatorium at Oakdale,
9 Iowa, be and the same are hereby appropriated, set aside and
10 ordered to be turned over the board of education of the
11 state.

1 Sec. 2. Said funds so appropriated and set aside, and
2 transferred to the board of education, shall be invested and
3 disbursed in the manner provided by said Acts of the 49th
4 General Assembly and of the 51st General Assembly and nothing
5 herein contained shall be construed so as to revert said funds
6 or any unexpended balance thereof to the general fund of the
7 state.

1 Sec. 3. The provisions of all acts or statutes in con-
2 flict or inconsistent with the provisions of this act are
3 hereby repealed.
