## A BILL FOR

An Act to amend sections six hundred fourteen point fourteen (614.14), six hundred fourteen point fifteen (614.15), six hundred fourteen point seventeen (614.17), six hundred fourteen point twenty (614.20), six hundred fourteen point twenty-two (614.22), and six hundred fourteen point sixteen (614.16), Code 1950, relating to special limitations of actions in regard to recovery of interests in real estate.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. Section six hundred fourteen point fourteen  
2 (614.14), Code 1950, is amended by striking from lines seven  
3 (7) and eight (8) the words and figures, "January 1, 1930"  
4 and inserting in lieu thereof the following, "January 1, 1940".

5 Further amend said section by striking from the last  
6 line the words and figures, "March 1, 1944", and inserting in  
7 lieu thereof the following, "March 1, 1952".

1 Sec. 2. Section six hundred fourteen point fifteen  
2 (614.15), Code 1950, is amended as follows:

3 1. Strike from line three (3) the figures "1930" and  
4 insert in lieu thereof the figures, "1940";

5 2. Strike from lines ten (10) and eleven (11) the words

6 and figures "July 4, 1943" and insert in lieu thereof the  
7 following, "July 4, 1951";

8 3. Strike from line twenty (20) the words and figures,  
9 "July 4, 1943" and insert in lieu thereof the following,  
10 "July 4, 1951".

1 Sec. 3. Section six hundred fourteen point seventeen  
2 (614.17), Code 1950, is amended by striking from lines two  
3 (2) and eleven (11) the figures "1930" and inserting in  
4 each instance the figures, "1940" in lieu thereof.

5 Further amend said section by striking from line  
6 sixteen (16) the figures "1943" and inserting the figures  
7 "1951" in lieu thereof.

1 Sec. 4. Section six hundred fourteen point twenty  
2 (614.20), Code 1950, is amended by striking from line  
3 nineteen (19) the word and figures "July 4, 1943" and  
4 inserting in lieu thereof the following, "July 4, 1951".

1 Sec. 5. Section six hundred fourteen point twenty-two  
2 (614.22), Code 1950, is amended by striking from line ten  
3 (10) the figures "1930" and inserting the figures "1940"  
4 in lieu thereof.

5 Further amend said section by striking from lines  
6 twelve (12) and fifteen (15) the figures "1945" and inserting  
7 the figures "1953" in lieu thereof.

8 Further amend said section by striking from line twenty-  
9 five (25) the figures "1943" and inserting the figures "1951"  
10 in lieu thereof.

1     Sec. 6. Section six hundred fourteen point sixteen  
2     (614.16), Code 1950, is hereby repealed and the following  
3     enacted in lieu thereof:  
4     “Section six hundred fourteen point fifteen (614.15),  
5     Code 1950, as amended by this act, shall not affect pending  
6     litigation, nor shall it operate to revive rights or claims  
7     previously barred, nor permit an action to be brought or  
8     maintained upon any claim or cause of action which is barred  
9     by any statute which is in force prior to July 4, 1951.”

EXPLANATION OF H. F. 222

The purpose of this bill is to bring forward for a period of 10 years the times provided in the various legalizing acts relating to adverse possession and related statutes. With the passage of 10 years from the last legislation of this type, the need for this legislation is apparent and is consistent with the practice of the Legislature for many years.
