## A BILL FOR

An Act to amend section two hundred thirty-one point eight (231.8), Code 1950, relating to the appointment and compensation of juvenile court probation officers and secretaries.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. Section two hundred thirty-one point eight  
2 (231.8), Code 1950, subsection two (2), is hereby amended  
3 by striking everything after the word "exceed" in line eight  
4 (8) and substituting in lieu thereof the following: "four  
5 thousand dollars (\$4,000.00) per year and such deputy  
6 probation officers may be appointed as may be necessary to  
7 carry out the work of the court. Such deputies shall be  
8 paid not to exceed three thousand dollars (\$3,000.00) per  
9 year."

1 Sec. 2. Section two hundred thirty-one point eight  
2 (231.8), Code 1950, subsection three (3), is hereby amended  
3 by striking everything after the word "exceed" in line  
4 four (4) and substituting in lieu thereof the following:  
5 "forty-five hundred dollars (\$4500.00) per year and such  
6 deputy probation officers may be appointed as may be necessary

7 to carry out the work of the court. Such deputies shall be  
8 paid not to exceed thirty-six hundred dollars (\$3600.00) per  
9 year.”

1 Sec. 3. Section two hundred thirty-one point eight  
2 (231.8), Code 1950, subsection four (4), is hereby amended  
3 by striking everything after the word “exceed” in line four (4)  
4 and substituting in lieu thereof the following: “fifty-four  
5 hundred dollars (\$5400.00) per year and such deputy probation  
6 officers may be appointed as may be necessary to carry out  
7 the work of the court. Such deputies shall be paid not to  
8 exceed four thousand dollars (\$4,000.00) per year.”

1 Sec. 4. Section two hundred thirty-one point eight  
2 (231.8), Code 1950, subsection five (5), is hereby amended  
3 as follows:

4 1. By striking the words “two thousand” (2000) in line  
5 six (6) and substituting in lieu thereof the words “twenty-two  
6 hundred” (2200).

7 2. By striking the word “four” (4) in line ten (10) and  
8 substituting in lieu thereof the word “seven” (7).

#### EXPLANATION OF H. F. 348

The purpose of this bill is to increase the salaries of the chief probation officers and deputy probation officers.
