A BILL FOR

An Act to amend chapter three hundred three (303), Code 1950, relating to the law, medical and traveling libraries and the department of history and archives.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section three hundred three point two (303.2),
2 Code 1950, is hereby amended by striking the period (.) at the
3 end thereof, and substituting in lieu thereof the following:
4 “, and a director appointed by the board of trustees.”

1 Sec. 2. Section three hundred three point three (303.3),
2 Code 1950, is amended as follows:

3 1. By striking from subsection two (2), line one (1)
4 the word “curator”, and substituting in lieu thereof the word
5 “director”.

6 2. By striking from subsection six (6), lines one (1) and
7 two (2) the word “curator”, and substituting in lieu thereof
8 the word “director”.

1 Sec. 3. Section three hundred three point five (303.5),
2 Code 1950, subsection four (4), is hereby amended by striking
3 everything therein and substituting in lieu thereof the following:

4 "Act under the directions of the director and the board
5 of trustees in all matters pertaining to the state law library."

1 Sec. 4. Section three hundred three point six (303.6),
2 Code 1950, is amended as follows:

3 1. By striking from line one (1) the word "curator", and
4 substitute in lieu thereof the word "director".

5 2. By striking from subsection one (1), line seven (7)
6 the word "curator", and substituting in lieu thereof the word
7 "director".

8 3. By striking from subsection six (6), line one (1) the
9 word "curator", and substituting in lieu thereof the word
10 "director".

11 4. By striking the period (.) at the end of subsection
12 eight (8) and adding thereto the following:

13 ", the Iowa state traveling library, the Iowa state law
14 library, the Iowa state medical library and the Iowa state
15 department of history and archives."

16 5. By adding thereto the following new subsection:

17 "Act as manager and director of the financial affairs and
18 the personnel of the four (4) departments."

1 Sec. 5. Section three hundred three point seven (303.7),
2 Code 1950, is hereby amended by striking from line one (1) the
3 word "curator", and substituting in lieu thereof the word
4 "director".

1 Sec. 6. Section three hundred three point eight (303.8),
2 Code 1950, is hereby amended by striking from line one (1)

3 the word "curator", and substituting in lieu thereof the word
4 "director".

1 Sec. 7. Section three hundred three point nine (303.9),
2 Code 1950, is amended as follows:

3 1. By striking from subsection two (2), line one (1) the
4 word "curator", and substituting in lieu thereof the word
5 "director".

6 2. By striking from line six (6) of said subsection the
7 word "curator", and substituting in lieu thereof the word
8 "director".

9 3. By striking from line seven (7) of said subsection the
10 word "curator", and substituting in lieu thereof the word
11 "director".

1 Sec. 8. Section three hundred three point ten (303.10),
2 Code 1950, is amended as follows:

3 1. By striking from lines eight (8) and nine (9) the word
4 "curator's", and substituting in lieu thereof the word
5 "director's".

6 2. By striking from line eleven (11) the word "curator",
7 and substituting in lieu thereof the word "director".

8 3. By striking from line twelve (12) the word "curator",
9 and substituting in lieu thereof the word "director".

10 4. By striking from line thirteen (13) the word "curator",
11 and substituting in lieu thereof the word "director".

1 Sec. 9. Section three hundred three point eleven (303.11),
2 Code 1950, is hereby amended as follows:

3 1. By striking from line three (3) the word "curator", and
4 substituting in lieu thereof the word "director".

5 2. By striking from line eight (8) the word "curator", and
6 substituting in lieu thereof the word "director".

1 Sec. 10. Section three hundred three point twelve (303.12),
2 Code 1950, is hereby amended as follows:

3 1. By striking from line two (2) the word "curator", and
4 substituting in lieu thereof the word "director".

5 2. By striking from line ten (10) the word "curator", and
6 substituting in lieu thereof the word "director".

1 Sec. 11. Section three hundred three point thirteen
2 (303.13), Code 1950, subsection two (2), is hereby amended by
3 striking everything therein and substituting in lieu thereof the
4 following:

5 "Act under the direction of the director and the board in
6 all matters pertaining to the state medical library."

1 Sec. 12. Section three hundred three point fourteen
2 (303.14), Code 1950, is hereby amended as follows:

3 1. By striking the period (.) at the end of subsection
4 one (1) and adding thereto the following:

5 ", and for such purpose a field worker shall be appointed."

6 2. By inserting in subsection two (2), line two (2),
7 following the word "trustees", the words "and the director".

8 3. By striking subsection three (3).

EXPLANATION OF H. F. 571

This bill proposes to put the four (4) libraries under one (1) director, who will be responsible to the board of trustees.
