A BILL FOR

An Act to legalize and validate the proceedings of the city council of the city of Spirit Lake, Iowa, authorizing and providing for the issuance and delivery of bonds for the construction of a City Hall and for the levy of taxes for the payment of said bonds, and declaring the bonds issued pursuant to said proceedings to be enforceable obligations of said city.

Whereas, it appears from the records of the city council of the city of Spirit Lake, Iowa, that at the regular city election held in and for said city on March 27, 1950, the proposition of issuing bonds of said city for the purpose of constructing a city hall to be used for general community and municipal purposes including a fire station and of levying a tax to pay said bonds and the interest thereon was approved by more than the required majority of the votes cast thereon and in reliance upon said election said city council thereafter by resolution authorized and provided for the issuance of city hall bonds of said city to the amount of fifty thousand dollars (\$50,000.00) for the purpose aforesaid and made provision for the levy of taxes to pay said bonds and interest thereon ; and

Whereas, it was found necessary and advisable to issue additional bonds to pay the cost of completing said city hall building and for that purpose the city council of said city has by resolution authorized and provided for the issuance of city hall bonds of said city in the amount of fifteen thousand dollars (\$15,000.00) and made provision for the levy of taxes to pay said bonds and the interest thereon ; and

Whereas, doubts have arisen concerning the validity and

legal sufficiency of said election and proceedings and provisions made for the issuance and payment of said bonds, and it is deemed advisable to put such doubts and all others that might arise concerning same forever at rest; now, therefore:

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. That all proceedings heretofore taken by the
2 city council of the city of Spirit Lake, Iowa, preliminary to
3 and in connection with the election held in said city on
4 March 27, 1950, and providing for the issuance, sale and delivery
5 of city hall bonds of said city in the aggregate principal
6 amount of sixty-five thousand dollars (\$65,000.00), and for the
7 levy of taxes to pay said bonds and interest thereon, are hereby
8 legalized, validated and confirmed, and said city hall bonds
9 issued and delivered pursuant to and in accordance with said
10 proceedings are hereby declared to be legal and to constitute
11 valid and binding obligations of said city.

1 Sec. 2. This Act being deemed of immediate importance
2 shall take effect and be in force from and after its passage
3 and publication in The Spirit Lake Beacon, a newspaper
4 published in Spirit Lake, Iowa, and in
5 Milford Mail, a newspaper published in
6 Milford, Iowa, all without expense to the state.

EXPLANATION OF H. F. 619

The purpose of this bill is to legalize a bond issue to finance the construction of a city hall in the city of Spirit Lake, Iowa.
