A BILL FOR

An Act to amend Sections three hundred twenty-one point one (321.1), three hundred twenty-one point four hundred fifty-seven (321.457), three hundred twenty-one point four hundred sixty-seven (321.467) and three hundred twenty-one point four hundred sixty-eight (321.468), Code 1950, relating to motor vehicles and law of road.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section three hundred twenty-one point one
2 (321.1), Code 1950, is hereby amended by striking subsection
3 eleven (11) of said section and enacting in lieu thereof the
4 following to be known as subsection eleven (11) of said
5 section:

6 11. "Trailer Coach" means either a trailer
7 or semi-trailer constructed or designed to permit
8 occupancy for dwelling or sleeping purposes.

1 Section 2. Section three hundred twenty-one point
2 four hundred fifty-seven (321.457), Code 1950, is hereby
3 amended by striking subsection three (3) of said section and
4 enacting in lieu thereof the following to be known as
5 subsection three (3) of said section:

6 3. No combination of truck tractor and semi-trailer,
7 nor any other combination of vehicles coupled together,
8 unladen or with load, shall have an overall length,
9 inclusive of front and rear bumpers, in excess of
10 forty-five (45) feet; provided, however, that the
11 restrictions hereinabove imposed by this subsection
12 shall not apply to a combination of trailer coach
13 and motor vehicle coupled together. No combination
14 of trailer coach and motor vehicle, when coupled
15 together, shall have an overall length, inclusive of
16 front and rear bumpers, in excess of fifty-five (55)
17 feet.

1 Section 3. Amend Section three hundred twenty-one
2 point four hundred sixty-seven (321.467) by striking the
3 period (.) at the end of said section and inserting in
4 lieu thereof a comma (,) and adding the following:

5 and provided further, however, that the state
6 highway commission or such local authorities may
7 in their discretion issue a special permit
8 authorizing the applicant to operate or move for
9 a distance in excess of twenty-five (25) miles a
10 combination of trailer coach and motor vehicle of
11 a size exceeding the maximum specified in this chapter.

1 Section 4. Amend Section three hundred twenty-one
2 point four hundred sixty-eight (321.468) by inserting after
3 the word "and" and before the word "load" in line three (3)
4 the words "the size or".
