A BILL FOR

An Act to amend section six hundred one point one hundred twenty-eight (601.128), Code 1950, relating to fees of justice.

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section six hundred one point twenty-eight
- 2 (601.128), Code 1950, is hereby amended as follows:

- 10 "twenty-five" (25) and insert in lieu thereof the word "fifty" (50).
- 11 In sub-section four (4) in line two (2) strike the words
- 12 "fifty cents" (50c) and insert in lieu thereof the words
- 13 "one dollar" (\$1.00).
- 14 In sub-section five (5) in line two (2) strike the words
- 15 "fifty cents" (50c) and insert in lieu thereof the words
- 16 "one dollar" (\$1.00).

17 In sub-section six (6) in line two (2) strike the word
18 “one dollar” (\$1.00) and insert in lieu thereof the words
19 “two dollars” (\$2.00).

20 In sub-section seven (7) in line two (2) strike the words
