A BILL FOR

An Act to make appropriations to Fern E. Sharp, Elkader, Iowa ;
Otto H. Henningsen, Clinton, Iowa ; Stanley L. Hart, Keokuk,
Iowa ; Lawrence Putney, Gladbrook, Iowa ; Henry Siefkas,
Osceola, Iowa and Harvey J. Long, Clinton, Iowa.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated out of the general
2 fund of the State of Iowa, to Fern E. Sharp, Elkader, Iowa, the
3 sum of four hundred forty dollars (\$440.00) in full settlement of
4 all claims which he may have against the State of Iowa on account
5 of services rendered as a member of the Legislative Advisory
6 Committee, State Office Building.

1 Sec. 2. There is hereby appropriated out of the general fund
2 of the State of Iowa, to Otto H. Henningsen, Clinton, Iowa, the
3 sum of three hundred eighty dollars (\$380.00) in full settlement
4 of all claims which he may have against the State of Iowa on
5 account of services rendered as a member of the Legislative Advisory
6 Committee, State Office Building

1 Sec. 3. There is hereby appropriated out of the general fund
2 of the State of Iowa, to Stanley L. Hart, Keokuk, Iowa, the sum of
3 four hundred forty dollars (\$440.00) in full settlement of all

4 claims which he may have against the State of Iowa on account of
5 services rendered as a member of the Legislative Advisory Committee,
6 State Office Building.

1 Sec. 4. There is hereby appropriated out of the general fund
2 of the State of Iowa, to Lawrence Putney, Gladbrook, Iowa, the sum
3 of three hundred eighty dollars (\$380.00) in full settlement of all
4 claims which he may have against the State of Iowa on account of
5 services rendered as a member of the Legislative Advisory Committee,
6 State Office Building.

1 Sec. 5. There is hereby appropriated out of the general fund
2 of the State of Iowa, to Henry Siefkas, Osceola, Iowa, the sum of
3 three hundred eighty dollars (\$380.00) in full settlement of all
4 claims which he may have against the State of Iowa on account of
5 services rendered as a member of the Legislative Advisory Committee,
6 State Office Building.

1 Sec. 6. There is hereby appropriated out of the general fund
2 of the State of Iowa, to Harvey J. Long, Clinton, Iowa, the sum of
3 four hundred dollars (\$400.00) in full settlement of all claims
4 which he may have against the State of Iowa on account of services
5 rendered as a member of the Legislative Advisory Committee, State
6 Office Building.

1 Sec. 7. The state comptroller is hereby authorized to issue
2 warrants to the above named parties in the amounts stated, and the
3 state treasurer is hereby directed to pay the same from the general
4 fund of the State of Iowa.
