## A BILL FOR

An Act to create a department of finance and to abolish the department of banking, the department of insurance, the securities department, the division of building and loan under the auditor of state, and the real estate commission and to transfer their powers and duties to the department of finance and to transfer the administration of laws relating to small loan and finance companies and chattel loans to the department of finance.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. Department created. There is hereby created  
2 a department of finance, with the commissioner of finance as  
3 the head thereof, which shall be located at the seat of  
4 government.

1 Sec. 2. Appointment and term. The governor shall,  
2 within sixty days following the organization of the regular  
3 session of the general assembly, in 1951, and each four  
4 years thereafter, appoint, with the approval of two-thirds of  
5 the members of the senate in executive session, a commissioner  
6 of finance, who shall be selected for his experience and  
7 known ability in important financial matters and serve for  
8 four years from July 1 of the year of appointment.

1     Sec. 3. Divisions. The department of finance shall  
2 include a banking division under the superintendent of banking,  
3 an insurance division under the superintendent of insurance,  
4 a securities division under the superintendent of securities,  
5 a building and loan division under the superintendent of  
6 savings and loan associations, a real estate division under  
7 the superintendent of real estate, and a division of small  
8 loan companies under the superintendent of small loan companies.

1     Sec. 4. Appointments. The finance commissioner shall  
2 appoint the superintendents of the several divisions of the  
3 finance department, who shall be responsible to him for the  
4 administration of their divisions, and who shall serve for  
5 terms concurrent with the commissioner's term of office.

1     Sec. 5. Salaries. The commissioner and division  
2 superintendents shall each receive such salary as the general  
3 assembly shall biennially provide.

1     Sec. 6. Vacancies. In the event that a vacancy occurs  
2 in the office of finance commissioner, the governor may fill  
3 such vacancy by temporary appointment for the unexpired term.  
4 Pending such temporary appointment the superintendent of  
5 insurance shall act as finance commissioner.

6     In the event that a vacancy occurs in the office of any  
7 division superintendent, it shall be filled in the same  
8 manner as original appointments are made.

1     Sec. 7. Powers of Commissioner. The finance commissioner  
2 shall have such powers and duties as are conferred on him by

3 law and may delegate the exercise or performance thereof to  
4 the proper division superintendent. The finance commissioner  
5 shall also have powers concurrent with those conferred by law  
6 on any division superintendent and may on suspicion of  
7 any of the grounds mentioned in sections sixty-six point one  
8 (66.1) or sixty-six point twenty six (66.26) suspend any  
9 division superintendent and take active charge of that  
10 division pending further investigation.

1 Sec. 8. On the effective date of this Act, the department  
2 of banking, the department of insurance, the securities  
3 department, the division of building and loan under the auditor  
4 of state, and the real estate commission shall cease to exist  
5 as such and the terms of all officers thereunder shall cease  
6 and determine. All records, papers, funds, and property  
7 pertaining to any of said departments, division, and  
8 commission shall on said date be turned over to the commissioner  
9 of finance and by him assigned to the proper division of his  
10 department.

1 Sec. 9. Wherever reference is made in the statutes,  
2 other than in this Act, to the commissioner of insurance, the  
3 code editor is authorized to change such reference so as to  
4 refer to the superintendent of insurance.

5 Wherever reference is made in the statutes, other than  
6 in this Act, to the real estate commission, the code editor  
7 is authorized to change such reference so as to refer to the  
8 superintendent of real estate.

9       Wherever reference is made in the statutes, other than  
10 in this Act, to the auditor of state, executive council, or  
11 supervisor of savings and loan associations, in connection  
12 with the administration of laws relating to building and loan  
13 or savings and loan associations, the code editor is  
14 authorized to change such reference so as to refer to the  
15 commissioner of finance.

16       Wherever reference is made in the statutes, other than  
17 in this Act, to the departments of insurance, banking, or  
18 securities, the code editor is authorized to change such  
19 references so as to refer to the department of finance.
