# A BILL FOR

An Act to create a department of conservation and natural resources and to abolish the Iowa natural resources council, the state conservation commission, the state soil conservation committee, and the geological board and to transfer their powers and duties to said department of conservation, and to transfer certain powers and duties of the executive council to said department.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. Department created. There is hereby created  
2 a department to be known as the department of conservation  
3 and natural resources.

1 Sec. 2. Commissioner appointed. The department of  
2 conservation and natural resources shall be in the charge  
3 of an officer to be known as the commissioner of conservation.  
4 Said commissioner shall be appointed by the governor with  
5 the approval in executive session of two-thirds of the senate  
6 for a two-year term of office. Any vacancy occurring in the  
7 office of commissioner shall be filled by appointment for the  
8 unexpired term made in the same manner as the original appointment  
9 except that if the General Assembly be not in session at the

10 time the vacancy occurs approval by the senate shall be deferred  
11 until it next is in session.

1 Sec. 3. Directors appointed. The commissioner shall  
2 appoint, with the consent of the governor, three directors to  
3 be known respectively as the director of wildlife and parks,  
4 the director of soil conservation, and the director of flood  
5 control.

1 Sec. 4 Compensation. The commissioner and each director  
2 shall receive such salaries as are fixed by the General Assembly.

1 Sec. 5. Duties of commissioner. The commissioner shall  
2 be in charge of the department of conservation and natural  
3 resources and shall have such powers and duties as are provided  
4 by law. He shall supervise each director in the performance  
5 of his duties and shall co-ordinate the affairs of the department  
6 so as to eliminate duplication of work and promote maximum  
7 administrative efficiency. He may delegate the performance  
8 of any duty assigned to him by law to the director whose duties  
9 are most closely related to the duty so delegated.

1 Sec. 6. Temporary. The Iowa natural resources council,  
2 the state conservation commission, the state soil conservation  
3 committee and the geological board are hereby abolished. On  
4 the effective date of this Act the terms of office of all  
5 members of said agencies shall cease and determine and the  
6 powers and duties of said agencies shall rest in and be  
7 exercised and carried out by the department of conservation  
8 and natural resources. All records, property, and pending

9 or unfinished business in the custody of or pertaining to said  
10 abolished agencies shall be turned over to the department of  
11 conservation and natural resources.
