A BILL FOR

An Act to create in the office of the secretary of state a division of occupational registration; to define the duties of said division; to transfer license issuing, clerical, and other administrative duties from certain examining boards to said division; and to amend various sections of the Code relating thereto.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Division created. There is hereby created in
2 the office of the secretary of state a division of occupational
3 registration for the purpose of furnishing administrative
4 assistance to boards of examiners constituted under the
5 provisions of title VIII of the Code and to the boards of
6 examiners for accountancy; architecture; engineering; mine
7 inspectors, foremen, and hoisting engineers; and watchmakers.

1 Sec. 2. Duties. The division of occupational registration
2 under the secretary of state shall perform the following duties
3 in respect to said examining boards:

4 1. Applications. Receive all applications for permits,
5 licenses, certificates, and examinations.

6 2. Examinations. Arrange for and assist in examinations.

7 3. Licenses. Issue licenses, permits, and certificates, as

8 ordered by said boards.

9 4. Fees. Collect and pay over to the treasurer of state
10 all fees provided by law for such licenses, permits, certificates,
11 and examinations.

12 5. Registers. Maintain registers of applicants and of all
13 licensed practitioners and business establishments.

14 6. Forms. Procure and furnish all forms necessary in
15 connection with such examinations and the issuance and renewal
16 or revocation of licenses, permits, and certificates.

17 7. Secretarial work. Perform all secretarial, stenographic,
18 and record keeping work necessary to enable such boards to carry
19 out their duties.

20 8. Signed certificates. Maintain on hand a supply of
21 certificates, licenses, and permits with the necessary signatures
22 affixed thereto.

23 9. Seals. Have custody of duplicates of the official seals
24 of said boards.

EXPLANATION OF S. F. 375

Sections one and two of this bill contain its substance which is to create a division of occupational registration in the office of the secretary of state which will be a central depository for records, registers of licensed practitioners and which will receive applications for examinations, assist examining boards in arranging for and conducting examinations, collect fees, issue licenses, permits, and certificates on order of the proper examining board, and generally perform all paper work and clerical functions for examining boards constituted by title XV of the Code and also for the boards of examiners for accountancy, architecture, engineering, watchmakers, and mine inspectors, foremen, and hoisting engineers.

Sections four to eighty-two of the bill are corrective sections for the purpose of amending existing statutes to conform to sections one and two of the bill.

Specifically:

1. Sections three and four amend the laws relating to licensing of mine foremen, inspectors, and hoisting engineers.

2. Sections five to fourteen amend the laws relating to licensing of civil engineers.

3. Sections fifteen and sixteen amend the laws relating to the licensing of accountants.

4. Sections seventeen and eighteen amend the laws relating to the licensing of architects.

5. Sections nineteen to twenty-three amend the laws relating to the licensing of watchmakers.

6. Sections twenty-four to thirty-two amend the laws relating to the issuance of basic science proficiency certificates.

7. Sections thirty-three to eighty-two amend the laws relating to licensing of certain professions and occupations affecting the public health.

All of said amendments are of a corrective nature designed to make the sections so amended consistent with sections one and two of this bill.
