## A BILL FOR

An Act fixing the number of senators in the general assembly, apportioning them among the several counties according to the number of inhabitants in each, and dividing the state into senatorial districts.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. The number of senators in the general assembly  
2 is hereby fixed at fifty, and they are hereby apportioned  
3 among the several counties according to the number of  
4 inhabitants in each, and under said apportionment the state  
5 is hereby divided into fifty senatorial districts, each  
6 district to have one senator, as follows:

7 1. Lee county shall constitute the first district.

8 2. Jefferson county and Van Buren county shall constitute  
9 the second district.

10 3. Appanoose county and Davis county shall constitute  
11 the third district.

12 4. Lucas county and Wayne county shall constitute the  
13 fourth district.

14 5. Decatur county, Ringgold county, and Union county  
15 shall constitute the fifth district.

- 16 6. Adams county and Taylor county shall constitute  
17 the sixth district.
- 18 7. Fremont county and Page county shall constitute the  
19 seventh district.
- 20 8. Mills county and Montgomery county shall constitute  
21 the eighth district.
- 22 9. Des Moines county shall constitute the ninth district.
- 23 10. Henry county and Washington county shall constitute  
24 the tenth district.
- 25 11. Clarke county and Warren county shall constitute
