Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. Section three hundred twenty-one point two
- 2 hundred eighty-six (321.286), subsection one (1), Code 1962,
- 3 is hereby amended by striking from line one (1) of said
- 4 subsection the word "Fifty" and inserting in lieu thereof
- 5 the word "Fifty-five (55)".

This bill would raise the truck speed limit from 50 to 55 miles per hour.
