## A BILL FOR

An Act to legalize and validate the proceedings of the board of directors of the Area Six Community School District, in the County of Muscatine, State of Iowa, authorizing and providing for the issuance of school building bonds and for the levy of taxes for the payment of said bonds and declaring the bonds issued pursuant to said proceedings to be enforceable obligations of said school district.

WHEREAS, it appears from the records of the board of directors of the Area Six Community School District, in the county of Muscatine, state of Iowa, that at a special school election held in and for said school district on April 23, 1962, the proposition of issuing bonds of said school district in the sum of six hundred thousand dollars for the purpose of carrying out a school building program consisting of building and furnishing two new Elementary School Buildings and procuring sites therefor was approved by more than sixty percent of the total number of votes cast for and against said proposition, and in reliance upon said election said board of directors thereafter by resolution authorized and provided for the issuance of school building bonds to the amount and for the purpose aforesaid and made provision for the levy of taxes to pay said bonds and the interest thereon; and

WHEREAS, doubts have arisen concerning the validity and legal sufficiency of said election and proceedings and provisions made for the issuance and payment of said bonds and it is deemed advisable to put such doubts and all others that might arise concerning same forever at rest; now, therefore,

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. That all proceedings heretofore taken
- 2 by the board of directors of the Area Six Community
- 3 School District, in the county of Muscatine, state of
- 4 Iowa, preliminary to and in connection with the elec-
- 5 tion on said bonds held in said school district on

6 April 23, 1962, and providing for the issuance and  
 7 delivery of school building bonds of said school district  
 8 in the amount of six hundred thousand dollars pursuant  
 9 to said election, and for the levy of taxes to pay said  
 10 bonds and interest thereon, are hereby legalized, vali-  
 11 dated and confirmed and said school building bonds  
 12 issued, sold and delivered pursuant to and in accordance  
 13 with said proceedings are hereby declared to be legal  
 14 and to constitute the valid and binding obligations  
 15 of said school district.

1 Sec. 2. This Act being of immediate importance  
 2 shall be in full force and effect from and after its  
 3 passage and publication in The Muscatine Journal, a  
 4 newspaper published at Muscatine, Iowa, and The West  
 5 Liberty Index, a newspaper published at West Liberty,  
 6 Iowa, without expense to the state.
