# A BILL FOR

An Act to amend section four hundred twenty-two point sixty-two (422.62), Code 1962, relating to funds for the manufacture of motor vehicle registration plates.

*House concurred in Senate Amendment 4/25 Passed bill 91-0*

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. Section four hundred twenty-two point sixty-two

2 (422.62), Code 1962, is hereby amended as follows:

3 1. By striking from lines eight (8) and nine (9) thereof the  
4 following: "four hundred twenty-five thousand dollars," and in-  
5 serting in lieu thereof the words: "a sufficient sum".

6 2. By striking from lines eighteen (18) and nineteen (19)  
7 thereof the words "at the end of the biennial period" and in-  
8 serting in lieu thereof the words "on October 31 of each year".

1 Sec. 2. This Act, being deemed of immediate importance, shall  
2 be in full force and effect from and after its passage and pub-  
3 lication in The Clarksville Star, a newspaper published at Clarks-  
4 ville, Iowa, and in The Dallas County News, a newspaper published  
5 at Adel, Iowa.

## EXPLANATION OF HOUSE FILE 157

Registrations increase every year as do costs of production of motor vehicle registration plates. It is practically impossible to estimate what these costs will be during an anticipated biennial period. This bill will allow the treasurer to transfer a sum sufficient to cover the costs of raw materials, supplies and manufacturing costs for production of motor vehicle registration plates.

Also this will provide for credit to the road use tax fund of unexpended balances as of October 31 of each year thus allowing and facilitating use of transferred funds for the full production year.

- 3 "a sufficient sum" and insert in lieu thereof "five hundred
- 4 thousand dollars".
- 5 2. Insert after subsection one (1) of section one (1) the

- 7 "2. Insert after the period in line seventeen (17) the
- 8 following: "The cost of any one year's registration plates
- 9 shall not exceed the appropriation as herein provided."
- 10 3. Renumber subsection two (2) of section one (1).
