A BILL FOR

An Act to legalize and validate the proceedings of the city council of the city of Denison, in Crawford County, Iowa, authorizing and providing for the issuance of airport bonds and for the levy of taxes for the payment of said bonds and declaring the bonds issued pursuant to said proceedings to be enforceable obligations of said city.

WHEREAS, it appears from the records of the city council of the city of Denison, in Crawford County, Iowa, that at a special election held in and for said city on October 19, 1962, the proposition of issuing bonds of said city in the amount of sixty thousand dollars (\$60,000) for the purpose of paying the cost, to that amount, of improving the municipal airport of said city was approved by more than sixty-five per cent (65%) of the total number of votes cast for and against said proposition, and in reliance upon said election said city council thereafter by resolution authorized and provided for the issuance of airport bonds of said city in the amount of sixty thousand dollars (\$60,000) for the purpose aforesaid and made provision for the levy of taxes to pay said bonds and the interest thereon; and

WHEREAS, doubts have arisen concerning the validity and legal sufficiency of said election and proceedings and provisions made for the issuance and payment of said bonds and it is deemed advisable to put such doubts and all others that might arise concerning same forever at rest; now, therefore,

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. That all proceedings heretofore taken by the
- 2 city council of the city of Denison, in Crawford County, Iowa,
- 3 preliminary to and in connection with the election on said bonds
- 4 held in said city on October 19, 1962, and providing for the
- 5 issuance and delivery of airport bonds of said city in the amount
- 6 of sixty thousand dollars (\$60,000) pursuant to said election,
- 7 and for the levy of taxes to pay said bonds and interest thereon,
- 8 are hereby legalized, validated and confirmed and said airport

9 bonds issued, sold and delivered pursuant to and in accordance
10 with said proceedings are hereby declared to be legal and to
11 constitute the valid and binding obligations of said city.

1 Sec. 2. This Act being of immediate importance shall be in
2 full force and effect from and after its passage and publication
3 in The Denison Review, a newspaper published at
4 Denison, Iowa, and The Denison Bulletin,
5 a newspaper published at Denison, Iowa, without
6 expense to the state.
