A BILL FOR

An Act to amend and repeal certain sections of chapter one hundred twenty-four (124), Code 1962, relating to beer and malt liquors.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section one hundred twenty-four point three (124.3),
2 Code 1962, is hereby amended as follows:

3 1. By strikng from line four (4) the following: " 'A', 'B'
4 or 'C' " and inserting in lieu thereof " 'A' or 'B' ".

5 2. By striking all after the period in line fourteen (14) and
6 all of lines fifteen (15), sixteen (16) and seventeen (17).

1 Sec. 2. Section one hundred twenty-four point five (124.5),
2 Code 1962, is hereby amended as follows:

3 1. By striking from line seven (7) the following: "and class
4 'C' permits".

5 2. By striking from line thirteen (13) the following: "and
6 'C' ".

7 3. By striking from lines twenty (20) and twenty-one (21) the
8 following: "or 'C' ".

9 4. By striking from line thirty-one (31) the following: "or
10 'C' ".

1 Sec. 3. Section one hundred twenty-four point ten (124.10),
2 Code 1962, is hereby repealed.

1 Sec. 4. Section one hundred twenty-four point eleven (124.11).

2 Code 1962, is hereby amended by striking from line seven (7) the
3 following " 'A', 'B' or 'C' " and inserting in lieu thereof the
4 following: " 'A' or 'B' ".

1 Sec. 5. Section one hundred twenty-four point thirteen
2 (124.13), Code 1962, is hereby repealed.

1 Sec. 6. Section one hundred twenty-four point twenty (124.20),
2 Code 1962, is hereby amended as follows:

3 1. By striking from lines sixteen (16) and seventeen (17)
4 the following: "or class 'C' ".

5 2. By striking from line twenty-six (26) the following: "or
6 class 'C' ".

7 3. By striking from lines twenty-eight (28) and twenty-nine
8 (29) the following: "or class 'C' ".

1 Sec. 7. Section one hundred twenty-four point twenty-four
2 (124.24), Code 1962, is hereby amended by striking from lines
3 twenty-seven (27) and twenty-eight (28) the following: "The
4 permit fee for class "C" permits shall be twenty-five dollars."

1 Sec. 8. Section one hundred twenty-four point twenty-seven
2 (124.27), Code 1962, is hereby amended by striking from line
3 seven (7) the following: "and class 'C' ".

1 Sec. 9. Section one hundred twenty-four point twenty-nine
2 (124.29), Code 1962, is hereby amended by striking from lines
3 one (1) and two (2) the following: "or class 'C' ".

1 Sec. 10. Section one hundred twenty-four point thirty-two
2 (124.32), Code 1962, is hereby amended by striking from line
3 three (3) the following: "or class 'C' ".

EXPLANATION OF HOUSE FILE 456

The purpose of this bill is to eliminate all provisions regarding a class "C" permit under the beer and malt liquors chapter. This will prevent the retail sale of beer, etc. in grocery stores, drug stores and other places making it more difficult for minors to obtain.
