A BILL FOR

An Act relating to the abolition of the state highway commission and its replacement with a state highway department.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Sections three hundred seven point one (307.1),
2 three hundred seven point two (307.2), three hundred seven point
3 three (307.3), three hundred seven point four (307.4), Code 1962,
4 are hereby repealed and the following enacted in lieu thereof:

5 "There is hereby created the Iowa state highway department.
6 The office of such department shall be located in the city of
7 Ames, Iowa. The chief officer of said department shall be known
8 as the state highway commissioner.

9 "The annual salary of the commissioner shall be twenty-five
10 thousand (25,000) dollars.

11 "The duties of the commissioner shall be:

12 1. To be the chief executive officer and oversee the opera-
13 tion and duties of the state highway department.

14 2. To appoint all assistants necessary to carry out the work
15 of the department, define their duties, fix their salaries sub-
16 ject to the approval of the state comptroller, provide for neces-
17 sary bonds and the amounts thereof.

18 3. To appoint a deputy commissioner who shall perform such
19 duties as the commissioner may direct. Such deputy shall have
20 power to act as commissioner in the absence or inability of the
21 commissioner to perform his duties.

22 4. To terminate the employment of any assistant at any time
23 for any cause."

EXPLANATION OF HOUSE FILE 458

The purpose of this bill is to abolish the highway commission and to provide for an elective commissioner. The duties of the present highway commission will be assumed by the state highway department under the commissioner.
