A BILL FOR

An Act relating to the state fair board.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section one hundred seventy-three point one

2 (173.1), Code 1962, is hereby amended as follows:

3 1. By striking from lines one (1) and two (2) of subsection

4 two (2) the words "A president and vice-president, and one di-

5 rector from each congressional district" and inserting in lieu

6 thereof the words "One (1) director from each congressional dis-

7 trict and three (3) directors at large".

8 2. By inserting after subsection two (2) the following:

9 "A president and vice-president to be elected by the state

10 fair board from the ten (10) elected directors."

1 Sec. 2. Section one hundred seventy-three point five (173.5),

2 Code 1962, is hereby amended by striking subsection one (1) of

3 such section and inserting in lieu thereof the following:

4 "A successor to each of the three (3) directors at large whose

5 term expires at noon on the day following the adjournment of the

6 convention. No two (2) directors at large shall be elected from

7 the same district."

1 Sec. 3. Section one hundred seventy-three point six (173.6),

2 Code 1962, is hereby amended by inserting in line eight (8) after

3 the word "chapter." the following:

4 "No person shall hold the office of president for more than

5 four (4) consecutive years.”

1 Sec. 4. Section one hundred seventy-three point eight (173.8),
2 Code 1962, is hereby amended by striking from line three (3) the
3 word “ten” and inserting in lieu thereof the word “twenty (20)”.

1 Sec. 5. Section one hundred seventy-three point sixteen
2 (173.16), Code 1962, is hereby amended by adding to such section
3 the following:

4 “An individual member of the state fair board shall not be
5 personally liable because of any act done or debt created by
6 action of the board in carrying out the purposes and provisions
7 of this chapter.”

EXPLANATION OF HOUSE FILE 463

The purpose of this bill is to enlarge the membership of the state fair board, to provide for the selection of officers from the personnel of the board, to make more realistic the expense allowance of the members, and to protect the members from personal liability for action taken by the board.
