A BILL FOR

An Act to legalize and validate the proceedings of the city council of Denison in Crawford County, Iowa, authorizing and providing for the issuance of street improvement bonds for paving, sanitary sewer and water mains and extensions, and for the levy of special assessments against benefited property for the payment of said bonds, and declaring the bonds issued pursuant to said proceedings to be enforceable obligations of the city of Denison, Iowa.

WHEREAS, it appears from the records of the city council of the city of Denison in Crawford County, Iowa, that by resolutions of necessity, the city of Denison, in accordance with Chapter 391A of the 1962 Code of Iowa, has provided for street improvements consisting of sanitary sewer, water installations and extensions and pavement on Twenty-fourth Street from its intersection with East Broadway to Second Avenue North, said improvements to be paid for by special assessments levied against the benefited property owners; and

WHEREAS, the city council of the city of Denison, Iowa, has, by resolution, authorized and provided for the issuance and sale of special assessment bonds for the payment of said improvements, in amounts of one thousand two hundred dollars (\$1,200.00) for water mains and extensions, twelve thousand two hundred dollars (\$12,200.00) for paving, and five thousand dollars (\$5,000.00) for sanitary sewer; and

WHEREAS, doubts have arisen concerning the validity and legal sufficiency of the proceedings and provisions made for the issuance and sale of said bonds and for the levy and collection of special assessments to pay the principal of and interest on said bonds as the same become due, and it is deemed advisable to put such doubts and all others that might arise concerning same, forever at rest; now, therefore,

Be It Enacted by the General Assembly of the State of Iowa:

- 1 Section 1. All proceedings heretofore taken by the
- 2 city council of Denison, in Crawford County, Iowa, providing
- 3 for the issuance, sale and delivery of special assessment
- 4 bonds of the city in the amounts of one thousand two hundred

5 dollars (\$1,200.00) for water mains and extensions, five
6 thousand dollars (\$5,000.00) for sanitary sewer and twelve
7 thousand two hundred dollars (\$12,200.00) for paving, to
8 pay the cost of the aforesaid street improvements, and for
9 the levy of special assessments to pay said bonds and interest
10 thereon, are hereby legalized, validated and confirmed and
11 said special assessment bonds issued, sold and delivered
12 pursuant to and in accordance with said proceedings are
13 hereby declared to be legal and to constitute valid and
14 binding obligations of said city.

1 Sec. 2. This act being of immediate importance shall be
2 in full force and effect from and after its passage and
3 publication in The Denison Bulletin, a newspaper published
4 at Denison, Iowa, and The Denison Review, a newspaper
5 published at Denison, Iowa, without expense to the state.
