## A BILL FOR

An Act relating to registration fees for certain motor vehicles for which the 1964 annual registration is the first registration.

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. Chapter three hundred twenty-one (321), Code  
2 1962, is hereby amended by adding the following new section:  
3 "The value for registration purposes of motor vehicles for  
4 which the 1964 annual registration is the first registration  
5 and for all motor vehicles registered for the first time after  
6 1964 shall be determined as follows:
- 7 1. At the time of the initial registration of a motor vehicle  
8 under this section, the applicant shall present to the county  
9 treasurer the window sticker which was affixed to the motor  
10 vehicle under the automobile information disclosure Act, Title  
11 15, chapter 28, United State Code.
- 12 2. The county treasurer shall set the value of the vehicle  
13 at the next even one hundred (100) dollars above the total price  
14 stated on such sticker.
- 15 3. The county treasurer shall state on the registration  
16 receipt the value so set which shall be the value used for  
17 renewal registration subject to the provisions of section  
18 three hundred twenty-one point one hundred thirteen (321.113)  
19 of the Code.
- 20 4. In the case of motor vehicles which are not subject to

21 Title 15, chapter 28, United States Code, the value of such  
22 vehicles shall be established by the department as provided for  
23 in sections three hundred twenty-one point one hundred fifty-  
24 seven (321.157) through three hundred twenty-one point one  
25 hundred sixty-two (321.162) of the Code except that the value  
26 so established shall include excise tax and the cost of all  
27 accessories attached to the vehicle at the time of sale to the  
28 applicant for registration.”

1 Sec. 2. Section three hundred twenty-one point one hundred  
2 nine (321.109), Code 1962, is hereby amended by inserting in  
3 line seven (7) after the word “department” the words “or county  
4 treasurer”.

1 Sec. 3. Section three hundred twenty-one point one hundred  
2 sixty-two (321.162), Code 1962, is hereby amended as follows:

3 1. By striking from line one (1) the word “The” and inserting  
4 in lieu thereof the words “For motor vehicles registered for  
5 the first time before the 1964 annual registration the”.

6 2. By striking from line three (3) the words “, and the  
7 weight” and inserting in lieu thereof the words “. The  
8 weight for all motor vehicles”.

#### EXPLANATION OF HOUSE FILE 568

The purpose of this bill is to use the manufacturer's suggested retail price as affixed to each new motor vehicle, as required by the Federal Automobile Information Disclosure Act, Title 15, chapter 28, United States Code, in fixing the value for figuring the annual registration fee on new cars.
