A BILL FOR

An Act relating to certain fees required by law to be paid to the department of agriculture.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section one hundred ninety-two point three (192.3),
2 Code 1962, is amended by striking from line two (2) the words
3 "one dollar" and inserting in lieu thereof the words "three
4 dollars".

1 Sec. 2. Section one hundred ninety-two point seventeen
2 (192.17), Code 1962, is amended by striking from line two (2)
3 the words "two dollars and fifty cents" and inserting in lieu
4 thereof the words "three dollars".

1 Sec. 3. Section one hundred ninety-four point fourteen
2 (194.14), Code 1962, is amended by striking from line three
3 (3) the word "two" and inserting in lieu thereof the word "three".

1 Sec. 4. Section one hundred ninety-five point nine (195.9),
2 Code 1962, is amended by striking from lines three (3) and four
3 (4) the words "one dollar" and inserting in lieu thereof the
4 words "three dollars".

1 Sec. 5. Section one hundred ninety-five point seventeen
2 (195.17), Code 1962, is amended by striking from subsection
3 two (2) the words "one dollar" and inserting in lieu thereof
4 the words "three dollars".

5 Further amend said section by striking from subsection three

6 (3) the word "one dollar" and inserting in lieu thereof the
7 words "three dollars".

1 Sec. 6. Section one hundred ninety-six point six (196.6),
2 Code 1962, is amended by striking from line two (2) the word
3 "two" and inserting in lieu thereof the word "three".

1 Sec. 7. Section one hundred ninety-six point seven (196.7),
2 Code 1962, is amended by striking from line four (4) the word
3 "two" and inserting in lieu thereof the word "three".

1 Sec. 8. Section two hundred fourteen point three (214.3),
2 Code 1962, is amended by striking from line five (5) the word
3 "three" and inserting in lieu thereof the word "five".

1 Sec. 9. Section one hundred sixty-six point ten (166.10),
2 Code 1962, is amended by striking from line one (1) of subsection
3 two (2) the words "one dollar" and inserting in lieu thereof the
4 words "three dollars".

1 Sec. 10. Section one hundred sixty-nine point eleven
2 (169.11), Code 1962, is amended by striking from line two (2)
3 of subsection three (3) the words "one dollar" and inserting in
4 lieu thereof the words "five dollars".

1 Sec. 11. Section one hundred seventy point five (170.5),
2 Code 1962, is amended by striking subsections one (1) to five
3 (5), inclusive, and inserting in lieu thereof the following:

4 "1. For a hotel containing thirty guest rooms or less, ten
5 dollars.

6 2. For a hotel containing more than thirty guest rooms and
7 less than seventy-six, fifteen dollars.

8 3. For a hotel containing more than seventy-five guest rooms
9 and less than one hundred fifty-one, twenty dollars.

10 4. For a hotel containing more than one hundred fifty guest

11 rooms, twenty-five dollars.”

12 Further amend said section by striking from subsection six

13 (6) the word “three” and inserting in lieu thereof the word

14 “five”.

1 Sec. 12. Chapter one hundred ninety-five (195), Code 1962,

2 is amended by adding a new section as follows:

3 “Any person who fails to renew any license required by this

4 chapter and pay the required fee on or before the date such

5 license is required to be renewed shall, at the time of such

6 renewal thereafter, pay a penalty fee of three dollars.”

EXPLANATION OF HOUSE FILE 569

This bill increases certain fees collected by the department of agriculture so that the necessary personnel could be provided for inspections. The present fund is nearly always depleted since there have been no increases in fees in spite of continually rising costs.
