## A BILL FOR

An Act relating to erection of buildings by soil conservation districts and the renting of space in such buildings.

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. Section four hundred sixty-seven A point seven
- 2 (467A.7), Code 1962, is hereby amended by adding thereto the
- 3 following new subsection:
- 4 "Subject to approval of the state soil conservation committee,
- 5 to borrow money, secure loans or mortgages for the purpose
- 6 of erecting, acquiring, or maintaining such buildings as may
- 7 be necessary or convenient for the performance of any of the
- 8 operations authorized by this chapter. Notes and other evidence
- 9 of indebtedness shall be general obligations of the district
- 10 and in no event shall they constitute an indebtedness of the
- 11 state soil conservation committee or of the state of Iowa.
- 12 A soil conservation district erecting any building under this
- 13 section may rent space in such building, and pledge the rents,
- 14 profits, and income received from any such building for the
- 15 liquidation of said indebtedness. After the debt is liquidated,
- 16 the district may use the rents, profits and income from such
- 17 building for maintenance of said building and for any other
- 18 purpose authorized by this section."

- 1 Amend Senate File 65 as follows.
- 2 1. By adding in line 13 after the word "may" the
- 3 words "as lessor".
- 4 2. By inserting in line 18 after the word "section."
- 5 the sentence:
- 6 "Such property shall not be exempt from property taxes."
