## A BILL FOR

An Act to change the method of arriving at maximum benefits payable on permanent partial disabilities, permanent total disabilities, temporary total disabilities, and healing period.

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. Amend section eighty-five point thirty-four
- 2 (85.34) subsection two (2), Code 1962, as follows:
- 3 1. By striking everything after the word "weeks" in line
- 4 two (2) of paragraph a. and inserting a period (.)
- 5 2. By striking everything after the word "weeks" in line
- 6 three (3) of paragraph b. and insert a period (.)
- 7 3. By striking everything after the word "weeks" in line
- 8 two (2) of paragraph c. and inserting a period (.)
- 9 4. By striking everything after the word "weeks" in line
- 10 two (2) of paragraph d. and inserting a period (.)
- 11 5. By striking everything after the word "weeks" in line
- 12 three (3) of paragraph e. and inserting a period (.)
- 13 6. By striking everything after the word "weeks" in line
- 14 two (2) of paragraph h. and inserting a period (.)
- 15 7. By striking everything after the word "weeks" in line
- 16 three (3) of paragraph i. and inserting a period (.)
- 17 8. By striking everything after the word "weeks" in line
- 18 two (2) of paragraph 1. and inserting a period (.)
- 19 9. By striking everything after the word "weeks" in line

- 20 five (5) of paragraph m. and inserting a period (.).
- 21 10. By striking everything after the word "weeks" in line  
22 two (2) of paragraph n. and inserting a period (.).
- 23 11. By striking everything after the word "weeks" in line  
24 five (5) of paragraph o. and inserting a period (.).
- 25 12. By striking everything after the word "weeks" in line  
26 two (2) of paragraph p. and inserting a period (.).
- 27 13. By striking everything after the word "weeks" in line  
28 three (3) of paragraph q. and inserting a period (.).
- 29 14. By striking the words "but not to exceed a total of  
30 one thousand eight hundred fifty dollars," following the word  
31 "weeks" in line two (2) of paragraph r. Further amend paragraph  
32 r. by striking everything after the word "weeks" in line six  
33 (6) of paragraph r. and inserting a period (.).
- 34 15. By striking everything after the word "such" in line  
35 five (5) of paragraph s. and inserting a period (.).
- 36 16. By striking everything after the word "weeks" in line  
37 eight (8) of paragraph t. and inserting a period (.).
- 38 17. By striking the words ", but not to exceed a total  
39 amount equal to the same percentage proportion of eighteen  
40 thousand five hundred dollars" following the word "whole" in  
41 line seven (7) of paragraph u. and inserting a period (.).
- 42 Further amend paragraph u. lines seventeen (17) and eighteen  
43 (18) by striking the words "maximum compensation" and inserting  
44 in lieu thereof the words "weeks". Further amend paragraph u. by  
45 striking all of lines nineteen (19), twenty (20), twenty-one (21)  
46 and twenty-two (22).
- 1 Sec. 2. Amend section eighty-five point thirty-four  
2 (85.34), subsection three (3), Code 1962, by striking all of

3 lines thirteen (13) through twenty (20) following the word  
4 "weeks" in line thirteen (13) and inserting a period (.)  
5 thereto.

1 Sec. 3. Amend section eighty-five point thirty-seven  
2 (85.37) Code 1962, by striking all of the portion of said  
3 section following the word "period" in line seven (7) and  
4 ending with and including the word "employee" in line twenty  
5 (20).
