A BILL FOR

An Act to amend certain sections of the subdistricts of soil conservation districts law.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section four hundred sixty-seven A point twenty
2 (467A.20), Code 1962, is hereby amended by inserting in line
3 forty (40) following the word "taxes" the following:
4 "with like penalty for delinquency,".

1 Sec. 2. Section four hundred sixty-seven A point twenty-
2 three (467A.23), Code 1962, is hereby amended as follows:

3 1. By inserting in line five (5) following the word "body"
4 the words "of the subdistrict".

5 2. By striking from line twenty-nine (29) the word
6 "commissioners" and inserting in lieu thereof the words
7 "governing body of the subdistrict".

1 Sec. 3. Section four hundred sixty-seven A point twenty-
2 four (467A.24), Code 1962, is hereby amended as follows:

3 1. By striking from line twenty-five (25) the word "watershed"
4 and inserting in lieu thereof the word "subdistrict".

5 2. By striking from line twenty-seven (27) the word "watershed"
6 and inserting in lieu thereof the word "subdistrict".

1 Sec. 4. Section four hundred sixty-seven A point thirty-
2 five (467A.35), Code 1962, is hereby amended as follows:

3 1. By striking from subsection one (1), line one (1), the
4 word "one-third" and inserting in lieu thereof the word

5 "one-half ($\frac{1}{2}$)".

6 2. By striking from subsection one (1) all of the sentence
7 after the word "agreement" in lines two (2) and three (3) and
8 inserting in lieu thereof the following:

9 "and the remaining one-half ($\frac{1}{2}$) shall become due and
10 payable one (1) year from the date of filing such agreement."

11 3. By striking from subsection two (2), line three (3), the
12 word "board" and inserting in lieu thereof the words "body
13 of the subdistrict".

14 4. By inserting in subsection two (2), line five (5), after
15 the word "body" the words "of the subdistrict".

16 5. By striking from subsection two (2) all after the period
17 in line five (5) and inserting in lieu thereof the following:

18 "The first (1st) installment of each assessment shall
19 become due and payable at the October semiannual tax paying
20 date after the date of filing such agreement, unless the
21 agreement is filed with the county auditor less than thirty (30)
22 days prior to such October semiannual tax paying date, in
23 that event, the first (1st) installment shall become due and
24 payable at the next succeeding October semiannual tax
25 paying date. The second (2nd) and each subsequent
26 installment shall become due and payable at the October
27 semiannual taxpaying date each year thereafter. All such
28 installments shall be collected with interest accrued on
29 the unpaid balance to the October semiannual taxpaying
30 date and as other taxes on real estate, with like penalty
31 for delinquency."
