A BILL FOR

An Act relating to life, health and accident insurance by employees of the state, county, city, town or institution supported by public funds.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Section three hundred sixty-five A point one
2 (365A.1), Code 1962, is repealed and the following enacted in
3 lieu thereof:

4 "The governing body of the state, county, city, town or any
5 institution supported in whole or in part by public funds may
6 establish plans for and procure group insurance, health or
7 medical service for the employees of the state, county, city,
8 town or tax-supported institution."

1 Sec. 2. Subsection two (2) of section three hundred sixty-
2 five A point two (365A.2), Code 1962, is repealed and the follow-
3 ing enacted in lieu thereof:

4 "Contributions authorized by the governing body from the
5 general fund of the public body in amounts not exceeding the
6 aggregate amounts assessed against and collected from employees
7 who elect to participate in any such plan. The funds for each
8 plan shall be kept separately."

1 Sec. 3. Section three hundred sixty-five A point three
2 (365A.3), Code 1962, is amended as follows:

3 1. By striking from line six (6) the words "city council"
4 and inserting in lieu thereof the words "governing body".

5 2. By striking from line eight (8) the word "city" and
6 inserting in lieu thereof the words "public body".

1 Sec. 4. Section three hundred sixty-five A point four
2 (365A.4), Code 1962, is amended by striking from line five (5)
3 the words "city council" and inserting in lieu thereof the
4 words "governing body".

1 Sec. 5. Section three hundred sixty-five A point five
2 (365A.5), Code 1962, is amended as follows:

3 1. By striking from line four (4) the words "city council"
4 and inserting in lieu thereof the words "governing body".

5 2. By striking from lines six (6) and seven (7) the words
6 "city council" and inserting in lieu thereof the words
7 "governing body".

1 Sec. 6. Section three hundred sixty-five A point six
2 (365A.6), Code 1962, is amended as follows:

3 1. By striking from line two (2) the words "city council"
4 and inserting in lieu thereof the words "governing body".

5 2. By striking from line two (2) the word "nonprofit".

6 3. By inserting in line four (4) after the word "chapter"
7 the figures "509,".

8 4. By striking from line twelve (12) the word "nonprofit".

9 5. By inserting in line fourteen (14) after the word
10 "chapter" the word and figures "509 or".

1 Sec. 7. Section three hundred sixty-five A point seven
2 (365A.7), Code 1962, is amended as follows:

3 1. By striking from line four (4) the word "city" and
4 inserting in lieu thereof the words "public body".

5 2. By striking from line twelve (12) the word "city" and
6 inserting in lieu thereof the words "public body".

1 Sec. 8. Section three hundred sixty-five A point eight
2 (365A.8), Code 1962, is amended by striking from lines one (1)
3 and two (2) the words "city council of cities" and inserting in
4 lieu thereof the words "governing body of public bodies".

1 Sec. 9. Section three hundred sixty-five A point ten
2 (365A.10), Code 1962, is amended as follows:

3 1. By striking from line two (2) the words "city council"
4 and inserting in lieu thereof the words "governing body".

5 2. By striking from line three (3) the words "city council"
6 and inserting in lieu thereof the words "governing body".

7 3. By striking from line eight (8) the words "city council"
8 and inserting in lieu thereof the words "governing body".

1 Sec. 10. Section three hundred sixty-five A point eleven
2 (365A.11), Code 1962, is amended as follows:

3 1. By repealing subsection one (1) and inserting in lieu
4 thereof the following:

5 "The words 'governing body' means the executive council of the
6 state, the board of supervisors of counties, the city or town
7 council of cities or towns and the superintendent or other person
8 in charge of an institution supported in whole or in part by
9 public funds."

10 2. By repealing subsection two (2) and inserting in lieu
11 thereof the following:

12 "The words 'public body' means the state, a county, city,
13 town or institution supported in whole or in part by public
14 funds."

1 Sec. 11. Section five hundred nine point four (509.4), Code
2 1962, is amended by striking from lines five (5), six (6) and
3 seven (7) the words "where the total number of employees to be

4 insured is less than twenty-five and more than four" and
 5 inserting in lieu thereof the words "including the state, a
 6 county, city, town or institution supported in whole or in part
 7 by public funds, but the number of employees to be insured must
 8 be more than four".

 26 4. By inserting in line six (6) after the comma following the
 27 word "life" the following: "accident."
 28 5. Amend by striking all of section 7 and inserting in lieu
 29 thereof the following:
 30 Sec. 7. Section three hundred sixty-five A point seven (365A.7),
 31 Code 1962, is hereby repealed and the following enacted in lieu
 32 thereof.
 33 "The word 'employee' as used in this chapter shall not include
 34 temporary or retired employees; however, nothing herein shall be
 35 construed as preventing a retired employee from voluntarily
 36 continuing in force, at his own expense, an existing contract."
