## A BILL FOR

An Act establishing a street research fund and regulating the use of such fund.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. Chapter three hundred twelve (312), Code 1962, is  
 2 hereby amended by adding thereto the following new section:  
 3 "There is hereby established a street research fund which  
 4 fund shall be used by the state highway commission solely for  
 5 the purpose of financing engineering studies and research proj-  
 6 ects which shall have as their objective the more efficient use  
 7 of funds and materials that are available for the construction  
 8 and maintenance of streets in cities and towns including bridges  
 9 and culverts located thereon. The research projects and engi-  
 10 neering studies authorized by this Act shall be conducted in co-  
 11 operation with the city engineers. Once each year the highway  
 12 commission shall file a report with the governor and city engi-  
 13 neers showing the work accomplished and projects undertaken under  
 14 this Act.

15 On or before January 1 of each odd numbered year a report shall  
 16 be filed with the chief clerk of the house of representatives and  
 17 the secretary of the senate showing the work accomplished and proj-  
 18 ects undertaken during the past biennium."

1 Sec. 2. Section three hundred twelve point two (312.2), Code  
 2 1962, is hereby amended by adding thereto the following new sub-

3 section:

4 "The treasurer of state shall before making the allotment to  
5 the street construction fund of cities and towns credit annually  
6 one-half (1/2) of one (1) percent of such street construction  
7 fund to the street research fund."

2 1. Amend Senate File 228 by striking all after the  
3 enacting clause and inserting in lieu thereof the following:  
4 Section 1. Chapter three hundred twelve (312), Code 1962, is  
5 hereby amended by adding thereto the following new section:  
6 "There is hereby established a street and farm to market  
7 road research fund which fund shall be used by the state highway  
8 commission solely for the purpose of financing engineering  
9 studies and research projects which shall have as their  
10 objective the more efficient use of funds and materials that  
11 are available for the construction and maintenance of streets  
12 in cities and towns including bridges and culverts located  
13 thereon and farm to market roads including bridges and culverts  
14 located thereon. The research projects and engineering studies  
15 authorized by this Act shall be conducted in cooperation with  
16 the city and county engineers. Once each year the highway  
17 commission shall file a report with the governor, city and  
18 county engineers showing the work accomplished and projects  
19 undertaken under this Act.  
20 On or before January 1 of each odd numbered year a report  
21 shall be filed with the chief clerk of the house of representa-  
22 tives and the secretary of the senate showing the work accom-  
23 plished and projects undertaken during the past biennium."  
24 Sec. 2. Section three hundred twelve point two (312.2),  
25 Code 1962, is hereby amended by adding thereto the following  
26 new subsection:  
27 "The treasurer of state shall before making the allotment  
28 to the street construction fund of cities and towns and farm to  
29 market road fund credit annually one-half (1/2) of one (1) percent  
30 of such street construction fund to the street research fund  
31 and one (1) and one-half (1 1/2) percent of such farm to market  
32 road fund to the secondary road research fund."  
33 Sec. 3. Sections three hundred ten point thirty-four  
34 (310.34), three hundred ten point thirty-five (310.35) and  
35 three hundred ten point thirty-six (310.36), Code 1962,  
36 are hereby repealed.
