## A BILL FOR

An Act to legalize and validate the establishment and operation of the public junior college department of the Clarinda Community School District, in the county of Page, state of Iowa.

WHEREAS, it appears from the records of the then existing Independent School District of Clarinda, Page county, Iowa, that the board of directors of said district, in the year 1923, established as a part of the school system of said school district a public junior college department offering educational courses in and above a four year high school course of study, which public junior college thereafter continued in being; and,

WHEREAS, on July 1, 1960, pursuant to a proper election, the entire territory embraced within the said Independent School District of Clarinda became a part of a new school corporation known as the Clarinda Community School District, in the county of Page, state of Iowa, and said new school corporation has continued with the operation of a public junior college using the same facilities formerly used by the Independent School District of Clarinda for such purpose; and,

WHEREAS, doubts have arisen concerning the legality and validity of the establishment and legal existence of the public junior college as a part of the school system of the Clarinda Community School District, in the county of Page, state of Iowa, and it is deemed advisable to put said doubts and all others that might arise concerning the same forever at rest: Now, therefore,

*Be It Enacted by the General Assembly of the State of Iowa:*

- 1 Section 1. That the steps taken in the organization and
- 2 establishment of a public junior college as a part of the
- 3 school system of the Independent School District of Clarinda,
- 4 Page county, Iowa, and the establishment and organization
- 5 of said public junior college as a part of the school system
- 6 of the Clarinda Community School District, in the county of
- 7 Page, state of Iowa, are hereby validated and declared to be

8 legal, and said public junior college is hereby declared to be  
9 duly and legally established and legally in operation, and all  
10 of the acts of the boards of education of the Independent  
11 School District of Clarinda, Page county, Iowa, and the  
12 Clarinda Community School District, in the county of Page,  
13 state of Iowa, relating to the establishment, organization  
14 and operation of said public junior college as a part of  
15 said school districts, shall be of the same force and effect  
16 as if the steps taken and the actions taken and done in the  
17 year 1923, and at all times since, had been duly and legally  
18 taken and legally authorized.

1     Sec. 2. This Act, being deemed of immediate importance,  
2 shall be in full force and effect from and after its passage  
3 and publication in The Clarinda Herald-Journal, a newspaper pub-  
4 lished in Clarinda, Iowa, and in The Essex Independent, a news-  
5 paper published in Essex, Iowa, all without expense to the  
6 state of Iowa.
