## A BILL FOR

An Act to raise the salary of the County Attorney and his assistants in counties having a population of one hundred fifty thousand (150,000) and over.

*Be It Enacted by the General Assembly of the State of Iowa:*

1 Section 1. By striking in line two (2) of sub-paragraph  
2 fifteen (15) of Section three hundred forty point nine (340.9),  
3 Code 1962, the words "ten thousand" and by inserting in lieu  
4 thereof the words "twelve thousand".

1 Sec. 2. By striking in line three (3) of sub-paragraph  
2 two (2) in Section three hundred forty point ten (340.10),  
3 Code 1962, the words "seventy-five" and by inserting in lieu  
4 thereof the words "eighty-five".

1 Sec. 3. By striking in line three (3) of sub-paragraph  
2 three (3) of Section three hundred forty point ten (340.10),  
3 Code 1962, the word "fifty" and by inserting in lieu thereof  
4 the words "sixty-five".

1 Sec. 4. By striking in line four (4) of sub-paragraph  
2 three (3) of Section three hundred forty point ten (340.10),  
3 Code 1962, the words "sixty-five" and by inserting in lieu  
4 thereof the words "eighty-five".
