A BILL FOR

An Act to amend chapter two hundred eighty-five (285), Code 1962, and to provide for the health, safety, welfare, and transportation of school children to and from school other than a public school.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. Amend section two hundred eighty-five point
 2 one (285.1), Code 1962, by striking lines one (1) through
 3 seven (7) of subsection one (1) and inserting in lieu there-
 4 of the following: "The board of directors in every school
 5 district shall provide transportation or the cost thereof for
 6 all resident pupils attending public school, and all resident
 7 pupils attending a private school of their choice within the
 8 respective school district, kindergarten through twelfth grade,
 9 who reside more than one mile from the public school designated
 10 by the board for attendance, or such private school notwith-
 11 standing the provisions of section three hundred forty-three
 12 point eight (343.8) of the Code, except as hereinafter provided:"
