## A BILL FOR

An Act to make appropriations to certain named persons in settlement of claims made against the state of Iowa.

*Be It Enacted by the General Assembly of the State of Iowa:*

1	Section 1. There is hereby appropriated out of the gas

4 indicated, claims for which were presented to the joint claims  
5 committee of the Sixtieth General Assembly.
