A BILL FOR

An Act to make appropriations to certain named persons in settlement of claims made against the state of Iowa.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated out of the
2 general fund of the state of Iowa to the following named
