A BILL FOR

An Act to appropriate from the general fund of the State of Iowa to the department of public safety for capital improvements for highway patrol buildings and for radio equipment for the division of radio communications.

Be It Enacted by the General Assembly of the State of Iowa:

1 Section 1. There is hereby appropriated to the division of
2 highway patrol, department of public safety, from the general fund
3 of the state the sum of one hundred five thousand dollars
4 (\$105,000.00), to be used for the purpose of constructing district
5 headquarters buildings at Denison, Osceola, and Mason City, Iowa.

1 Sec. 2. Contracts, plans and specifications for the buildings
2 for which funds are herein appropriated shall be of similar de-
3 sign and construction as those provided for by the Fifty-eighth
4 General Assembly and shall be submitted to the budget and finan-
5 cial control committee for approval, except that items commonly
6 known as change orders need not be submitted to the budget and
7 financial control committee for approval unless such change orders
8 actually increase the total cost of a particular building or
9 buildings.

1 Sec. 3. There is hereby appropriated to the public safety de-
2 partment, division of radio communication, from the general fund
3 of the state the sum of two hundred thousand dollars
4 (\$200,000.00), to be used in purchasing radio equipment to re-
5 place the mobile units now in service. Replaced equipment shall

6 first be offered to public schools at an amount equal to the
7 trade-in allowance as accepted.

1 Sec. 4. Before any of the funds herein appropriated shall be
2 expended it shall be determined by the department of public
3 safety, with the approval of the budget and financial control
4 committee, that the expenditure shall be for the best interest of
5 the state.

1 Sec. 5. Any unencumbered balance remaining as of June 30,
2 1967, of the appropriations of this Act made by the Sixtieth
3 General Assembly, shall revert to the general fund of the state.

1 Sec. 6. This Act being deemed of immediate importance shall be
2 in full force and effect from and after its passage and publica-
3 tion as provided by law, in the Glenwood Opinion-Tribune, a
4 newspaper published at Glenwood, Iowa, and in The Madrid Regis-
5 ter-News, a newspaper published at Madrid, Iowa.
