1 A Resolution honoring the University of Iowa
2 Women's Basketball Team and Coach Lisa Bluder.

3 WHEREAS, the citizens of Iowa are justifiably proud
4 that the University of Iowa Hawkeyes Women's
5 Basketball Team finished its regular season with an
6 overall record of 17 wins and 10 losses; and

7 WHEREAS, the Iowa Women's Basketball Team was led
8 by senior guard Lindsey Meder who was the Big Ten's
9 top 3-point scorer and one of just four players to be
10 unanimously selected to the All-Big Ten first team by
11 the coaches; and

12 WHEREAS, sophomore Jennie Lillis was named to the
13 second team by the media and was an All-Big Ten
14 honorable mention by the coaches; and

15 WHEREAS, for the second straight year Lindsey Meder
16 has been selected to the Verizon Academic All-District
17 first team with a GPA of 3.95 in psychology and
18 premedicine; and

19 WHEREAS, the Iowa Women's Basketball Team led the
20 Big Ten with 18.4 assists per game, ranked second in
21 the Big Ten in scoring offense with 77.5 points, and
22 fourth in field goal percentage of 44.9; and

23 WHEREAS, sophomore Jennie Lillis and senior Jerica
24 Watson were named Big Ten Players of the week; and

25 WHEREAS, the Iowa Women's Basketball Team received
26 the number nine seed in the Mideast Region of the
27 National Collegiate Athletic Association (NCAA)
28 tournament and won their first-round NCAA Tournament

2 WHEREAS, the Iowa Women's Basketball Team's NCAA
3 appearance marked the 14th and second consecutive NCAA
4 Tournament appearance for the team, which is the most
5 by any women's basketball team in the Big Ten; NOW
