18 constitutional majority of the Senate and the House of

20 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES, THE
21 SENATE CONCURRING, That Mr. William P. Angrick II is
22 approved and confirmed as the Citizens' Aide for a
23 four-year term which commences July 1, 2005, as
24 provided in sections 2C.3 and 2C.5.
