**A BILL FOR**

1 An Act making an appropriation from the healthy Iowans tobacco  
2 trust to the Iowa department of public health for tobacco use  
3 prevention and control.

1 Section 1. HEALTHY IOWANS TOBACCO TRUST -- APPROPRIATION  
2 TO IOWA DEPARTMENT OF PUBLIC HEALTH. There is appropriated  
3 from the healthy Iowans tobacco trust created in section 12.65  
4 to the Iowa department of public health for the fiscal year  
5 beginning July 1, 2005, and ending June 30, 2006, the  
6 following amount, or so much thereof as is necessary, to be  
7 used for the purposes designated:

8 For the tobacco use prevention and control initiative,  
9 including efforts at the state and local levels, as provided  
10 in chapter 142A:

11 ..... \$ 19,300,000

12 1. The director of public health shall dedicate sufficient  
13 resources to promote and ensure retailer compliance with  
14 tobacco laws and ordinances relating to persons under 18 years  
15 of age, and shall prioritize the state's compliance in the  
16 allocation of available funds to comply with 42 U.S.C. § 300x-  
17 26 and section 453A.2.

18 2. Of the amount appropriated in this section, a portion  
19 of the amount shall be utilized to provide for enforcement of  
20 tobacco laws, regulations, and ordinances under a chapter 28D  
21 agreement entered into between the Iowa department of public  
22 health and the alcoholic beverages division of the department  
23 of commerce.

24 3. Of the funds appropriated in this section, not more  
25 than \$525,759 shall be expended on administration and  
26 management of the initiative.

27 4. Of the funds appropriated in this section, not less  
28 than 80 percent of the amount expended in the fiscal year  
29 beginning July 1, 2001, for community partnerships shall be  
30 expended in the fiscal year beginning July 1, 2005, for that  
31 purpose.

32 EXPLANATION

33 This bill appropriates moneys from the healthy Iowans  
34 tobacco trust to the Iowa department of public health for  
35 tobacco use prevention and control, including efforts at the

1 state and local levels. The bill also directs the director of  
2 public health to dedicate sufficient resources to promote and  
3 ensure retailer compliance with tobacco laws and ordinances  
4 relating to persons under 18 years of age, and to prioritize  
5 the state's compliance in the allocation of available funds;  
6 allows that a portion of the amount appropriated is to be  
7 utilized to provide for enforcement of tobacco laws,  
8 regulations, and ordinances under a Code chapter 28D agreement  
9 entered into between the Iowa department of public health and  
10 the alcoholic beverages division of the department of  
11 commerce; limits the amount of moneys appropriated to be used  
12 for administration of the program; and provides that of the  
13 amount appropriated, not less than 80 percent of the amount  
14 expended in the fiscal year beginning July 1, 2001, for  
15 community partnerships is to be expended in the fiscal year  
16 beginning July 1, 2005, for that purpose.
