1 Section 1. APPROPRIATION -- TREASURER OF STATE -- COUNTY  
2 FAIRS. There is appropriated from the rebuild Iowa  
3 infrastructure fund to the office of treasurer of state for  
4 the fiscal year beginning July 1, 2006, and ending June 30,  
5 2007, the following amount, or so much thereof as is  
6 necessary, to be used for the purpose designated:

7 For county fair infrastructure improvements for  
8 distribution in accordance with chapter 174 to qualified fairs  
9 which belong to the association of Iowa fairs:

10 ..... \$ 1,060,000

11 Notwithstanding section 8.33, unencumbered or unobligated  
12 moneys remaining at the end of the fiscal year shall not  
13 revert but shall remain available for expenditure during the  
14 following fiscal year for purposes of county fair  
15 infrastructure improvements.

16 EXPLANATION

17 This bill appropriates \$1.06 million from the rebuild Iowa  
18 infrastructure fund to the office of treasurer of state for  
19 county fair infrastructure improvements for distribution in  
20 accordance with Code chapter 174 to qualified fairs which  
21 belong to the association of Iowa fairs. Any unencumbered or  
22 unobligated moneys remaining at the end of the fiscal year  
23 shall not revert to the rebuild Iowa infrastructure fund, but  
24 shall remain available for expenditure during the following  
25 fiscal year for purposes of county fair infrastructure  
26 improvements.
