1 Section 1. Section 123.49, subsection 2, Code 2005, is
2 amended by adding the following new paragraph:

3 NEW PARAGRAPH. 1. Sell, give, possess, or otherwise

6 form.

7 **EXPLANATION**

8 This bill prohibits a person or club holding a liquor
9 control license or retail wine or beer permit, or their agents
10 or employees, from selling, giving, possessing, or providing a
11 machine designed to dispense an alcoholic beverage in a
12 vaporized form. Pursuant to the provisions of Code section
13 123.50, a violation of the provisions of the bill is a simple
14 misdemeanor and is grounds for the revocation or suspension of
15 the person's license or permit.

AN ACT
